The Medina Township Board of Trustees met in regular session at the Medina Township Hall on February 7th, 2008, to conduct the business of the Township. President Todd called the meeting to order at 7:04 pm with the following Trustees in attendance: Rita M. Holt, Michael D. Todd and Mead Wilkins. Also in attendance were the Fiscal Officer, Police Chief, Fire Chief, Zoning Inspector, Assistant Zoning Inspector and the general public.

Roll Call

Mr. Todd asked for a roll call of all members present. Trustees present were Mrs. Holt, Mr. Todd and Mr. Wilkins.

Mr. Todd led the Pledge of Allegiance.

Accounts Pavables

Mrs. Holt motioned to approve accounts payable checks #18334 to #18382 totaling \$41,869.46. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Wilkins.

Approval of Minutes

Mr. Wilkins motioned to approve the appropriation of \$915 for Brian Mummert to attend 120 hour Firefighter One training at the Medina County Career Center from February 18 to April 23. Mr. Todd seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Wilkins.

Road Department

The Road Foreman reported that for the month of January 2008, the Road Department cleaned and maintained buildings, equipment and vehicles; installed repaired and replaced signs as needed; plowed and salted roads; received 3 salt deliveries; worked on sign and road inventory; refaced Blakslee Park sign; picked up dead deer; cleaned up fallen trees and limbs; cleaned up catch basins and opened culverts; picked up yard waste dumped in River Trace; had meeting regarding Remsen Culvert; met with OTARMA Insurance rep and responded to 2 daytime fire calls.

Road Department Accumulation of Sick Time for Overtime

Mr. Wilkins said the road department will get sick leave accumulation for overtime in excess of 80 per pay period or 40 hours per week.

Mr. Todd motioned to approve the three (3) department reports presented. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Wilkins.

Resolution for the Soil ands Water Conservation District

Mr. Wilkins followed up with Jeff Van Loon and the concerns are whether or not they can have three (3) separate definitions between Hinckley, Liverpool Township and Medina Township and was told it was not a problem. Mr. Wilkins will check with Mr. Van Loon and then the Trustees will vote on the wording of the *Local Preference Area*.

Longevity Pay Clarification

Mr. Wilkins motioned that longevity pay be for full time employees only after their third year of employment at \$100 per year for 2008, and this would be reviewed on an annual basis hereafter. Mrs. Holt seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Wilkins. Mr. Todd motioned to amend the motion to state that this motion shall supersede all previous representations and agreements to Township personnel. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Huffman.

Pay Rates for Part-Time Road Department Personnel

Mr. Wilkins motioned that the 2008 pay rates for Paul Cugini, Sr. and Scott Vargo be \$15.78 per hour. Don Kessler and Jeff Kessler be \$17.17 per hour and part-time Firefighters who work for the Road Department be \$12.50 per hour. Mr. Todd seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Wilkins.

Mrs. Holt motioned to table the appointments of the Zoning Commission and Zoning Board of Appeals Members. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Wilkins.
