Linda Berry and Sue Joyce voiced their concerns about the trucks carrying dirt to a neighbor's property and the damage being done to the road and the two (2) bridges on Cook Road. There is also a pile of dirt at least 6 to 7 stories high. Mr. Todd and Mr. Wilkins had the Police and Road Departments go to the site and take pictures and movies of the road damage. The Police have cited the trucks that were overweight. The Trustees have contacted the Prosecutors Office regarding recouping the cost to repair the road. They have asked the Highway Engineers office for a cost estimate to repair the road. The ladies asked if it was legal to discharge automatic weapons in the Township. A letter will be sent to Soil and Water asking if a permit was issued.
