## Lumina Imaging & Diagnostics-3985 Medina Rd.

Mr. Bryan Crowley from Lumina Imaging and Mr. Jeff O'Donnell partner and vendor of the equipment that would be used in this business operation were present to represent Lumina Imagining and Diagnostics. This business would consist of both CT and MRI imaging capability.

Chair stated for the record this business would be locating in an existing building i.e. Western Reserve which is located at 3985 Medina Rd.

The comments from Fire Chief Crumley were as follows: Permits need to be obtained from Medina County Bldg. Department Prior to opening the applicant will need to contact the Fire Department for a fire/safety inspection.
