The Medina Township Board of Trustees met in regular session at the Medina Township Hall on April 26th, 2012, to conduct the business of the Township. Chairman Todd called the meeting to order at 7:05 pm with the following Trustees in attendance: Michael D. Todd, Ray Jarrett and Ken DeMichael. Also in attendance were the Fiscal Officer, Police Chief, Fire Chief, Road Foreman, Zoning Inspector and the general public.

Roll Call

Mr. Todd asked for a roll call of all members present. Trustees present were Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Pledge

Mr. Todd led the Pledge of Allegiance.

Moment of Silence

Mr. Todd asked for a moment of silence for our military personnel serving at home and overseas.

OTHER BUSINESS

Police Officer Michael Oyler Award

Mr. Todd read a letter received from the son of a woman regarding Officer Michael Oyler's life saving measures that, by performing CPR that started her heart beating again, enabled the family to have closure with her before she passed away. Officer Oyler was then presented with a Certificate of Recognition and a life saving award pin for his uniform. Chief Arbogast said the pin has one star and he may have to take it back for one with 2 stars because just before this meeting Officer Oyler performed CPR on a gentleman and was able to get his heart beating again.

SITE PLANS

Cutler Real Estate - Site - 3647 Medina Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the change of use for Cutler Real Estate to be located at 3647 Medina Road as presented. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Master Pruning Nursery - Site - 3875 Pearl Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the change of use for Master Pruning to be located at 3875 Pearl Road as presented. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Master Pruning Nursery - Wall Sign - 3875 Pearl Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve a wall sign for Master Pruning not to exceed 60 square feet as presented. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Master Pruning Nursery - Directional Signs - 3875 Pearl Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve a directional sign for Master Pruning not to exceed 4 square feet as presented. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

OTHER BUSINESS CON'T

Creative Housing

Diane DePasquale Haggarty of Creative Housing contacted Mr. Todd about possibly using the garage portion of the Township's newly purchased building for their supportive employment enclaves. They do vocational training and employment for all 7 schools districts in Medina County. Mr. Jarrett asked how much space they would require and how long they would want to use it. Ms. Haggarty said they are flexible and they would like to move in by the school year in August. Mr. Jarrett felt that this was great for the Community and the Township would assist. Mr. DeMichael asked where the vehicles were stored now and was told they are spread out all over. Mr. Todd said this would also meet the vocational requirements needed for this building. Mr. Jarrett said there would be public hearings before selecting who would use the building.

Approval Accounts Payables

Mr. Todd motioned to approve warrant #22941 to #22981 in the amount of \$44,600.09. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Approval of Payroll

Mr. Todd motioned to approve payroll checks #15933 to #15954 total amount of \$24,923.48 with \$4,758.36 going to union dues, post tax health, OPERS and Deferred Comp. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Approval of March Bank Reconciliation

Mr. Todd motioned to approve the bank reconciliation for the month of March and incorporate by reference document dated April 22, 2012, at 4:38 pm. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Approval of Supplemental Appropriations

Mr. Todd motioned to approve the supplemental appropriations of \$23,500.00 for account number 1000-130-221 and \$1,180.00 for account number 1000-130-229. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Approval of Minutes

Mr. Todd motioned to approve minutes for the April 12 regular meeting and April 17 special meeting. Mr. DeMichael seconded the motion. Roll call vote: Mr. Todd aye, Mr. DeMichael aye and Mr. Jarrett abstain. (Mr. Jarrett was not at those meetings)

DEPARTMENT REPORTS

Zoning Department

Elaine Ridgley, Zoning Inspector, reported that for the month of March 2012, 29 permits were issued as follows:

Total value of permits issued was \$500,400.00 with total fees collected of \$4,708.12. Security Deposits returned in March: \$2,250.00. 2 Violations issued to: Doraty KIA of Medina.

DEPARTMENT REPORTS CON'T

Police Department

Chief Arbogast reported that for the month of March 2012, there were 816 calls for service; he said drug activity is picking up (see attached). The Emergetech system is moving along slowly and the new police cars have been ordered.

The Chief discussed a meeting that was held with Montville Township regarding shared services specifically, sharing a detective. The detective would be one of Montville's Officers. There is a JAG grant that can be applied for that would pay for a detective. There are a lot of details that have to be decided upon but Mr. Todd wanted to ask the other Trustees for their approval before the grant is applied for and before they finalize discussions.

The department received two mobile data terminals from Homeland Security. The consoles, hardware and up to \$150 for installation costs was all provided by the Homeland Security grant.

Fire Department

Chief Crumley reported that for the month of March 2012, the department responded to 22 calls for service and performed 10 inspections (see attached).

LST Contract

Mr. Todd and Mr Jarrett attended a meeting with Mr. Thorne in Montville Township regarding the LST Contract. The Trustees did not accept the contract and asked that the contract be redone. Mr. Todd said the contract treats the Townships and City as subordinates and not as the owners of the LST. The hospital took ownership as if it was their department, their equipment and their property. They put the rules in the contract in such a way that they had unilateral control over the budget and of how much they were going to offset services. It was pretty close to being a one-sided contract. The Trustees are hoping it was just an oversight because of a change in Administration. Mr. Jarrett said they told Mr. Thorne he had 60 days to get back to us with an update, whether it is an agreement or not, because we are under a time frame due to the LST levy coming up for renewal this Fall.

Service Department

Denny Miller, Road Foreman, reported that for the month of March 2012, the department salted roads; attended 2012 Budget Meeting; took a salt delivery; did general maintenance on trucks; bermed roads; met with Brunswick Hills regarding roadside mowing; had all building water backflows tested; serviced roadside mower; had traffic light on Grande Blvd changed to LED lights; serviced Ford Fusion; met Treemasters at Remsen Cemetery; fixed plow damage along township roads; cold patched roads; hauled 5 loads of 411 limestone to stockpile; got quotes for Dumpster Days; prepared ballfields for season; worked on baseball and soccer schedules.

Mr. Todd motioned top accept the March 2012, departmental reports. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

OLD BUSINESS

Status of Flag Day, Community Pick-it-up-Day and Dumpster Day

Mr. Todd is working on the speaker for Flag Day and everything is in place for Pick-it-up-Day.

PURCHASE ORDERS AND TRAINING REQUESTS

Dumpsters for 1st Annual Dumpster Days

Mr. Todd motioned to appropriate \$600.00 for C. Martin Trucking for the 4 40-yard dumpsters for the Township for Dumpster Day. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

PURCHASE ORDERS AND TRAINING REQUESTS

Medina County Sanitary Engineers - Tipping Fees

Mr. Todd motioned to appropriate \$3,000.00 for tipping fees for the Township Dumpster Days for the Medina County Sanitary Engineers. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

OLD BUSINESS CON'T

Temporary Inflatable Signs-Zoning Amendment

Mr. Todd said Trustees presented the text amendment change document to the Zoning Commission and the Commission scheduled a workshop to review the document for May 8 at 7:00 pm. Asst. County Prosecutor Bill Thorne or a representative will attend that workshop.

PURCHASE ORDERS AND TRAINING REQUESTS CON'T

Fabrizi Disposal, Inc. - Dumpsters

Mr. Todd motioned to appropriate \$330.00 for Fabrizi Disposal, Inc. for 2 40-yard dumpsters for scrap steel. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd and Mr. DeMichael.

Tri-City Communications, Inc. - Fire Department - Kenwood Mobile Radios

Mr. Jarrett motioned to appropriate, for the Fire Department, for an amount of \$1,595.00 to Tricity Communications, Inc. This is for Kenwood mobile radios and 4 hours to install the radios. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Mitchell Communications-Fire Department - Motorola Minitor Pagers

Mr. Jarrett motioned to appropriate \$4,202.00; vendor information being Mitchell Communications out of Akron, Ohio, these are for Motorola pagers and also there is a warranty that is included in this, a five year warranty. Mr. Todd seconded the motion. Voting aye thereon: Mr. Todd and Mr. DeMichael.

Finley Fire Equipment - Miscellaneous Hose for 201-3

Mr. Jarrett motioned to appropriate \$15,201.00; vendor information being Finley Fire Equipment out of McConnelsville, Ohio for miscellaneous hose for the new engine. Mr. Todd seconded the motion. Voting aye thereon: Mr. Jarrett, Mr. Todd and Mr. DeMichael.

Fire Force, Inc. - Miscellaneous Equipment for Truck 201-3

Mr. Jarrett motioned to appropriate \$4,259.20; vendor information is the Fire Force, Inc. out of Boardman, Ohio. This is for small equipment for the new engine and this ranges anywhere from adapters, to strainers, combination nozzles, portable generator, that is just a few items, man hole hooks (there was discussion during the motion before the second that will not be included in the motion). Mr. Todd seconded the motion. Voting aye thereon: Mr. Jarrett, Mr. Todd and Mr. DeMichael.

Finley Fire Equipment – Miscellaneous Small Equipment for 201-3

Mr. Jarrett motioned to appropriate \$11,603.00, vendor information being Finley Fire Department out of McConnelsville, Ohio; these are for small miscellaneous items for the new engine. Again, that range anywhere from adapters for the truck, shut off nozzles, the Honda Generator and miscellaneous tools. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Jarrett, Mr. DeMichael and Mr. Todd.

Mr. Jarrett asked when the truck would be finished, in service, delivered and shown to the public. The truck will be delivered May 7 and they hope to have the truck in service in 2 months. The old fire engine will be kept in reserve. The truck will not need to be replaced for 20 to 25 years.

Enforcing Zoning Code Training for Laurie Shoemaker

Mr. DeMichael motioned to appropriate \$25.00 for continuing Education for Laurie Shoemaker attending a professional planning and zoning workshop in December. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Jarrett and Mr. Todd.

Tri-City Communications - Narrow Band for Service

Mr. DeMichael motioned to appropriate \$3,770.00 for some narrow band for Tri-City Communications in Barberton, for some narrow band radios and the reprogramming of them as well; this is for the Service Department. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Jarrett and Mr. Todd. Mr. Jarrett asked how many radios this was for and Mr. Miller said 12, one for each truck.

There was discussion regarding the problems with the new Emergetech Dispatch System. The Township has to go with the Emergetech System because we contracted with City for dispatching.

ADDITIONAL DEPARTMENT HEAD COMMENTS

Police Department

Chief Arbogast said there was a combined training with Medina City and Medina Township Police and Fire, LST and the Emergency Management Agency for a simulated chemical spill at the AT&T Tower. It went well and was a required training. The next one will be at the AT&T site on Fenn. Also, the DUI Task Force will be out in force on Friday night at Route 18 and 71.

Fire Department

Chief Crumley presented Trustees with the signed Hydrant Agreement and a picture of the sign. They will be going up soon. He also presented Trustees with the tentative scope of work agreement for the District Study with the City and Montville Township.

The Chief presented Trustees with the billing breakdown provided by Ohio Billing for accidents involving non-residents that the Township can bill for. Mr. Todd said to get a contract from Ohio Billing. Mrs. DeHoff questioned how the information is provided to the company and is there someone on staff at the Township right now that could do this. The Trustees said it takes a lot of time to do the billing. Alliss Strogin said Lafayette Township does the soft-billing to the resident's insurance company. Mr. DeMichael said it was explained to him that soft-billing would make everyone's insurance go up and we need to investigate that more. Mr. Jarrett said to move forward and just have a one-year trial period.

Chief Crumley said May 2 is Dunkin-Donuts (Route 18) 31 cent Scoop Night from 6 to 8 pm. and the General Manager of the facility will donate the proceeds to the National Fallen Firefighters Foundation.

Chief Crumley said they are going to swear in 7 new recruits and he asked if Trustees wanted to hold a special meeting on May 15 at Fire Station 2 at 7:00 pm.

Chief Crumley thanked everyone who sent attended his son's services.

OTHER BUSINESS

Study for the Property on Remsen & Myers Roads

The Trustees had reviewed the documents from SAS and LMG. Mr. Jarrett spoke with both companies and found them to be excellent companies with good references. He said LMG was very prompt and provided him with all the information he requested. Mr. DeMichael asked about the asbestos in the building. Mr. Traves, from LMG, said the asbestos issue was not incorporated in their proposal. Mr. Todd said when something is identified as having an environmental impact as you move into the building, should you take some action later, you're not going to be subject to some types of fines and other things that may come up through EPA compliance issues. However, if you forgo that process should environmental issues come up, there is a potential that you could be levied some fines and other things by the EPA because you didn't have record or documentation that the environmental issues pre-existed your occupation of that property.

Study for the Property on Remsen & Myers Roads Con't

Mrs. DeHoff said Lori Wallace will attend a Trustee meeting and discuss her proposal for checking the building for asbestos. Mr. Todd said the sewage pump does not have an EPA permit and it is not running. The wood floor has an awful odor and needs to be looked at.

Bill Ostmann (3670 Hamilton Road) said he was told by the EPA that a permit was needed for his sewage system. He said he never new that this permit existed. He feels it would be cost effective for the Township to have a study done on the new building.

Matt Galla (3503 Hamilton) asked about the floor and was told it is the floor in the garage. He also commented on the sewage pump station for the Highway Patrol Building.

Chief Arbogast said the Commissioners gave the Township a 15 day extension. Mr. Todd asked Chief Arbogast to work on the asbestos assessment and contact Ms. Wallace regarding her availability to do the assessment.

Mr. Traves said to ask her specifically if she is doing a PLMR Analysis because survey can be a lot of different things. She will then be able to prepare a better quote.

Mr. Todd motioned to appropriate \$2,450.00 for the Phase I environmental review of the Remsen Road property that the Township has entered into a purchase agreement with the county for Labrynth Management Group and incorporate by reference the original proposal and all accompanying addendums that have been provided to Trustee Jarrett. Mr. Jarrett seconded the motion. Roll call vote: Mr. Todd aye, Mr. Jarrett aye and Mr. DeMichael no.

NEW BUSINESS

Ohio Cooperative Purchasing Program Resolution

Mr. Todd motioned the following resolution authorizing Medina Township to participate in the State of Ohio Cooperative Purchasing Program (see attached). Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael

PUBLIC COMMENT

Mr. Todd motioned to open the floor for public comment. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Dianna Huffman (4025 Remsen Road) asked what the cost of sharing a detective with Montville would be and Mr. Todd said that is being looked into. Mrs. Huffman asked if there was any formal training to be a detective and Mr. Todd said there is no special certification.

Sally Gardner (3333 Foskett Road) said she asked PSE if Chief Arbogast would have been able to get a loan for the leased Police Cars and she was told no. She said Easy Money Casino Day Senior Day will be May 15 at the fairgrounds from 9am to 3pm, cost is \$3.00. She commented on the Leadership Medina County Meeting program regarding Medina County Growth Forum Past and Future. The Weymouth Preservation Society is holding a Plant Sale/Swap on May 5th from 10am to 1 pm at the building on Remsen & Myers Road.

Bill Ostmann (3670 Hamilton Road) asked about the survey or questionnaire that was discussed at the last Steering Committee meeting.

Don Kessler (5126 Baker Road) asked about the garage area on the new property and if it was the same garage Creative Housing was asking and Mr. Todd said yes.

PUBLIC COMMENT

Robin Gray (4074 Remsen Road) asked if the 14 students participating in the program get hurt is the township libel. Mr. Todd said they would discuss that with legal counsel. Mrs. Gardner asked if it would be the same as if someone fell in the townhall and Mr. Todd said yes. Ms. Gray updated the Trustees on the fracking issue.

Mr. Todd motioned to close the floor for public comment. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Comprehensive Plan Survey/Questionnaire

Mr. Todd said a questionnaire is a blank document that you send in the mail and people respond and send it back to you. A survey is much more pointed and directed at a specific audience. There is a certain demographic group they you try to meet with a survey. Mr. Todd feels a questionnaire should be done up front and then do a structured survey later. Mr. Jarrett said Kirby Date is going to give the names of several companies that do questionnaires and surveys. Mr. Todd said before they go to public hearings a survey should be done. Mr. Ostmann said he feels a questionnaire should be done quickly so the Committee is sure they are doing what the residents want. Mr. DeMichael asked about the cost and how much time it is going to take.

Dianna Huffman (4025 Remsen Road) said the township did a cost of services study years ago. Mr. Todd said he has read it. Mr. Ostmann will bring his copy.

Mr. Todd said the Township provides services to people through roads and we don't get revenue. The City is allowed to assess income tax to people who work in the City but live in the Township. The City says they are providing free parks to our residents. Mr. Todd feels Township residents contribute to the parks through payroll taxes paid to the City.

Chief Arbogast discussed the Community Development Block Grant. He would like to work with Creative Housing and use the grant to provide handicapped bathrooms in the section of the building they would be using. The Trustees gave their approval to apply for the grant.

Mr. Todd motioned to adjourn the meeting at 9:59 pm. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.
