Mr. Overmyer made a motion to approve the use for Soccer Post Medina to be located at 3705 Pearl Rd. Unit E as presented. It was seconded by Ms. Szunyog. ROLL CALL- Overmyer-yes, Apana-yes, Szunyog-yes, Kuenzer-yes, Strogin-yes.

Mr. Elliott stated he was also present to request signage. The first sign request was for a 25 sq. ft. wall sign. The business has 25 ft. of linear frontage.
