# RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING JUNE 6<sup>TH</sup>, 2013

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on June 6<sup>th</sup>, 2013, to conduct the business of the Township. Chairman Todd called the meeting to order at 7:03 pm with the following Trustees in attendance: Michael D. Todd, Ray Jarrett and Ken DeMichael. Also in attendance were the Fiscal Officer, Police Chief, Fire Chief, Road Foreman, Zoning Inspector and the general public.

#### Roll Call

Mr. Todd asked for a roll call of all members present. Trustees present were Mr. Todd, Mr. Jarrett and Mr. DeMichael.

#### **Pledge**

Mr. Todd led the Pledge of Allegiance.

#### **Moment of Silence**

Mr. Todd asked for a moment of silence for our military personnel at home and overseas.

# **Approval of Accounts Payables**

Mr. Todd motioned to approve warrant #24144 to #24188 in the amount of \$71,767.82. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

# **Approval of Payroll**

Mr. Todd motioned to approve payroll checks #17255 to #17314 in the amount of \$42,586.83 with \$6,469.94 going to union dues, OPERS, post tax health and Deferred Comp. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett

# **Approval of Minutes**

Mr. Todd motioned to approve the minutes for the April 25<sup>th</sup> and May 9<sup>th</sup>, 2013, regular meeting. Mr. Jarrett seconded the motion. Mr. Todd withdrew the motion and Mr. Jarrett withdrew his second.

Mr. Todd made a renewed motion to approve the April 25<sup>th</sup>, 2013, regular meeting minutes. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Mr. Todd motioned to approve the May 9<sup>th</sup>, 2013, regular meeting minutes. Mr. Jarrett seconded the motion. Roll call vote: Mr. Todd aye, Mr. Jarrett aye and Mr. DeMichael abstain.

Mr. Jarrett motioned to approve the May 23<sup>rd</sup>, 2013, regular scheduled meeting. I'd like to make a motion for the May 30<sup>th</sup>, 2013 special meeting, also. Mr. DeMichael seconded the motion. Roll call vote: Mr. Jarrett aye, Mr. DeMichael aye and Mr. Todd abstain.

# **Temporary Inflatable Sign Zoning Amendment**

Mr. Todd asked the status of the Temporary Inflatable Zoning Amendment and was told by Mrs. Strogin that there was no change from the last meeting.

### **Medina Soccer Association Draft Lease**

Mr. Todd said there weren't a lot of changes to the draft MSA lease. Ian Jones of MSA would like to eliminate the security deposit section of the draft lease. Mr. Todd and Mr. Jarrett agreed. Mr. DeMichael would like the rental fee numbers checked because he thought the fees were more. The Trustees reviewed the previous minutes. Mr. DeMichael said the portion for the first part was \$750.00 per month, \$9,000.00 annually and he thought that when they talked about renting the second part it was the same, \$750.00 per month. Mr. Todd said no it was prorated, per square foot, and the total number is right. Mr. Todd said one question he had was that he thought the Township agreed to 20% but Mr. Jones has it that MSA has agreed to pay Medina Township 10% of the profits. Chief Arbogast said there were two different levels, one was outside groups and the other was over and above expenses. Mr. Jones's recommendation was instead of doing two different levels after their expenses then we get 10% of any income over and above that. Mr. Todd said his recollection is that there are two different levels. There was registration amount and then the amount for outside usage of the fields. Mr. Jarrett said the master draft agreement states that we can review the lease every 5 years. He feels we should review the lease annually including annually reviewing the 10%. Mr. Jarrett said we have the right to annually look at the monthly payment during the first five years which is up to a 10% ceiling and then an initial term of 5% annually for the next five years, so if we have the same language, to also look at that addendum. Mr. Todd said to put something separate to say "MSA agrees to pay Medina Township 10% of any net profit at the end of each calendar year. The net profit would be money left over after revenue generated." Mr. Todd said he would say "MSA agrees to pay Medina Township a set percentage of any net profit at the end of each calendar year. The net profit will be any money left over after the revenue generated through activities at the HIVE, after all expenses related to the HIVE have been paid in full. For the initial term of the lease this percentage rate is 10% to be negotiated annually." Mr. DcMichael asked what are all expenses related to the HIVE and is that there whole lease. Mr. Todd said it's related to the floor, cleaning up, doing all the things that they do. Mr. Jarrett said there is referee expense and advertising. Mr. DeMichael said we are not going to see anything extra. Mr. Todd said that is why we need to put language in the lease that we can renegotiate annually. Chief Arbogast said MSA has no problem with the Township auditing their books.

# **Frontier Contract**

Mr. Todd motioned to enter into a Service Agreement with Frontier Communications and incorporate by reference this service agreement that is four (4) pages long. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Mr. Todd motioned to incorporate a Schedule One (1) Maintenance Schedule to the fee agreement which is three (3) pages long. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

#### Flag Day Ceremony

Mr. Todd asked Mrs. Shoemaker the status of the Flag Day Ceremony June 8<sup>th</sup>, 2013, at 4:00 pm and was told everything is on schedule. She said the program will be held outdoors this year. There also is a soccer tournament at Blakslee fields so she is having the National Guard come to help direct traffic and Mr. Miller will post signs showing where the Flag Day parking will be. She also said Medina Township residents will vote on the Flag Design and Mr. DeMichael will present an award to the winner. The essay contest winners were all 4<sup>th</sup> grade ladies. The Trustees had no idea who they were.

# Fencing at Weymouth Cemetery

Mr. Todd said Mr. Miller had samples of the fencing but he doesn't think Weymouth Preservation Society will approve of them. He asked Mr. Miller to show them to Susan McKiernan. They would have to go with vinyl or wood. The wood would need to be maintained.

# **Weymouth Cemetery Contract**

The Respectful Internment Preservations contract was received from Tom Karris and distributed to the Trustees and Mr. Russell of RIP. They will review it and make their decision on the approval at the June 20 Trustees meeting.

# **Weymouth Preservation Society Report**

Mrs. Gardner reported that the Weymouth Preservation Society now has 201 members. They will have a window display at the Medina Convention Center on the Square for the month of June. They have received four (4) cleaning kits to clean the stones at the cemetery and they may get help from two (2) Ashland College History Majors who live in the Township. She thanked the Trustees for the new cemetery sign. A petition is being put together to change the name from S. Weymouth Road to Old Weymouth Road. The Post Office will still deliver mail marked S. Weymouth Road. She asked the Trustees if they would offer a letter of support to the County Commissioners. The Trustees said after they get75% of the signatures they will make a decision. There will be an open house this Sunday (June 9).

Mr. Miller has been trying to contact the architect regarding the roof at the Remsen Road building. He will keep Trustees informed.

Mr. Miller got the price of \$75.00 each for 2 inch oaks, lindens or sweet gums from Davis Tree Farm. He can't replace all the trees but would like to put them down the middle of the paths to shade the parents who watch the games. It would be about \$1,000.00.

# Northeast Ohio Public Energy Council

Mr. Jarrett attended a meeting the County Commissioners held with all County Townships and the Northeast Ohio Public Energy Council. They are the largest retail aggregation in the nation. They discussed natural gas and they are non-profit pro consumer, dedicated to lowering your utilities. They would like input from the Townships asking if they want Natural Gas Aggregation put on the November ballot Township by Township or County wide. He would like the information put on the website. A decision needs to be made by August 7, 2013.

# Sen. Brown Announces Resources to Bolster Firefighter Safety in Medina County

FY 2012 Funding Will Help to Improve Preparedness and Response of Firefighters in Medina

#### Thursday, June 6, 2013

WASHINGTON, D.C. – New federal resources have been awarded to a fire department in Medina County. U.S. Senator Sherrod Brown (D-OH) today announced that the Medina Township Fire Department has been awarded resources for operations and safety by the U.S. Department of Homeland Security's (DHS) Federal Emergency Management Agency (FEMA) Assistance to Firefighters Grants (AFG) program.

"Our first responders put their lives on the line every day across Ohio," said Brown. "These funds ensure that firefighters in Medina have the resources they need to perform their jobs safely."

This is round 29 of the competitive Fiscal Year 2012 AFG announcements. The Medina Township Fire Department received \$132,896 in funding.

The Assistance to Firefighters Grants (AFG) program helps firefighters and other first responders purchase protective equipment, vehicles, and gear, according to FEMA.
