## RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING FEBRUARY 27<sup>TH</sup>, 2014

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on February 27<sup>th</sup>, 2014, to conduct the business of the Township. Chairman Todd called the meeting to order at 7:05 pm with the following Trustees in attendance: Michael D. Todd, Ken DeMichael and Ray Jarrett. Also in attendance were Fiscal Officer DeHoff, Police Chief Arbogast, Lieutenant Schmitt, Road Foreman Miller, Zoning Inspector Ridgley and the general public.

#### Roll Call

Mr. Todd asked for a roll call of all members present. Trustees present were Mr. Todd, Mr. DeMichael and Mr. Jarrett.

#### **Pledge**

Mr. Todd led the Pledge of Allegiance.

#### Moment of Silence

Mr. Todd asked for a moment of silence for our military personnel at home and overseas.

#### SITE PLANS

#### The Painted House and More - Sign - 3833 Pearl Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the signage for The Painted House and More at 3833 Pearl Road, not to exceed 31.13 square feet as submitted. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the panel sign, the panel not to exceed 5.34 square feet for the identification sign for The Painted House and More at 3833 Pearl Road as presented. Mr. DeMichael motioned to approve the January 30, 2014, regular meeting minutes. Mr. Jarrett seconded the motion. Roll call vote: Mr. DeMichael aye, Mr. Jarrett aye Mr. Todd abstain.

Mr. DeMichael motioned for a purchase order requisition for a, the vendor is Cargill Deicing Technology. We purchased 2200 tons of road salt, \$34.32 a ton or \$7,550.40. Mr. Jarrett seconded the motion. Mr. Todd asked if we had done well on salt. Mr. Miller said he still had 350 tons left and that is all he can purchase for the year. He is at his 120%. Voting aye thereon: Mr. DeMichael, Mr. Jarrett and Mr. Todd.

Mr. Todd motioned to approve a purchase order requisition in the amount of \$244.00 payable to the Greater Medina Chamber of Commerce for 2014. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

# <u>Tiffen Metal Products - Evidence Room - Police Department</u>

Mr. Todd motioned to approve a purchase order requisition in the amount of \$14,988.00 for the evidence pass through and lockers located at the Police Department building payable to Tiffin Metal Production. Mr. DeMichael seconded the motion. Mr. Todd asked Chief Arbogast if this was something that has been needed for a long time. Chief Arbogast said yes. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

#### REPORTS/DEPARTMENT HEAD COMMENTS

# Zoning Department

Elaine Ridgley reported that for the month of December 2013, 12 permits were issued as follows:

Detached Cluster I Commercial Addition I
Commercial Change of Use 2 Signs 7
Temporary Trailer I

Total value of permits issued was \$314,000.00 with total fees collected of \$1,831.74.

For the month of January 2014, 5 permits were issued as follows:

Commercial Change of use 3 Signs 2
Total value of permits issued was \$315,000.00.

Mr. Todd asked if there was any progress on Gateway. Mrs. Ridgley said she has to review each property and is working on it.

#### Police Department

Chief Arbogast presented Trustees with his annual report. Mr. Todd asked that he extrapolate out the community policing part of the report.

The formal Medina County Drug Interdiction Task Force began today. Several departments are involved and this is an asset to our community. We have five (5) Officers that have been specially trained for highway interdiction. 171 is a major drug route in this area and there is a heroin epidemic. They are trying to eliminate drugs in our area.

Twelve (12) contractors attended the pre-bid meeting for the new Police Department. They got the Governor in and out of town with no incidents.

#### Fire Department

Lt. Schmitt talked about community awareness regarding Metro Health Medical Center in conjunction with Case Western Reserve University performing a study called Pre-hospital Air Medical Plasma Trial (see attached). This is for trauma treatment (shock or uncontrolled bleeding). If no one can be found to speak for the patient or the patient cannot speak for themselves they will automatically be enrolled in this study. The community does have the opportunity to opt-out of this program. Mr. Jarrett said Metro Health Medical Center in conjunction with Case Western Reserve University will conduct the research study. Mr. Todd said plasma is given when there is no time or knowledge of the patients' blood type.

#### Service Department

Denny Miller reported that for the month of December 2013, the department plowed and salted roads; received 559.38 tons of salt; cleaned and repaired trucks as needed; picked up office furniture for new Police Department; submitted ODOT sign grant for \$15,465.37; started new equipment storage building; worked on 2014 baseball schedule; installed load limit signs on township roads and replaced light timer for pole light at townhall.

#### Road Salting Procedures

Mr. Miller asked for permission to cut back on salting the developments that are 25 miles per hour as much as they are because of the salt shortage, we cannot get any more salt. He would continue to salt intersections, hills and roads as usual. Mr. Todd said it would be okay for the remainder of the year but that would not be their policy. Mr. Jarret told him to use his discretion. Mr. Miller said for just an FYI, we have spent nearly \$58,000.00 for salt this year.

Mr. DeMichael read a letter from the Reserve Homeowners Association commending the Road Department for the great job they are doing keeping the roads clear and salted.

#### **Timber Creek Drive**

Mr. Miller has received calls regarding the pond on Timber Creek Drive, in the valley, that feeds into Lake Medina. It is completely drained because there is a hole down there. Mr. Miller said the county called him but it is not our pond. Mr. Jarrett asked what caused that and Mr. Miller said it is just old age.

Mr. Todd motioned to approve the December 2013, departmental reports and the annual departmental report for the Police Department and the Zoning Department. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

#### **OLD BUSINESS**

#### Request for Streetlight at Intersection of Rivendale and Fenn Road

Mr. Miller has been trying to reach the gentleman at Ohio Edison and has not had a response as of this date. Mr. Todd tabled this item until we hear from Ohio Edison.

#### **NEW BUSINESS**

# Public Hearing Continuance Date - Zoning Text Amendments

Mr. Todd said due to family issues had by Mr. DeMichael and himself a new date needs to be set for the Public Hearing Continuance. He said Mr. Jarrett brought up some issues and a letter will be sent to the Prosecutor for clarification of those issues. Mr. Jarrett said to be sure there is clarification as to whether the Board of Trustees were in the statutory requirements required and what the remedy is. Mr. Todd said he will get the information from the beginning of when it was originally submitted to the Zoning Commission. Mrs. Strogin said there are statutory limits as to when this is supposed to be done, the continuing of the public hearings, and when that process stopped and there is no longer a legitimate public hearing date, she asked if that means that the motions from the Zoning Commission are now law. Mr. Todd said no because the Zoning Commission does not have the authority to do that. It has to be an action taken by the Board of Trustees. Mr. Todd said the Trustees will get legal advice from the Prosecutor.

#### Public Hearing Continuance Date

Mr. Todd motioned to set the continued public hearing for the text amendments for Medina Township to be on March 20, 2014, at 7:00 pm. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

#### OTHER BUSINESS

## Weymouth Preservation Society Report

Mr. Gardner said they are waiting for estimates from plasterers and electricians. Mr. Miller said he received one quote from an electrician of \$1,300.00 for material and labor. Mrs. Gardner said they are getting ready to start work on the windows and someone from the society will be there while they are working. The next open house will be on April 13, 2014, from 2:00 to 4:00 pm and the topic will be on township history. There is a link on the township website for the Weymouth Preservation Society.

# Removing Event Pictures from Website Homepage

The Trustees gave permission to remove the pictures of events on the homepage since they can be seen on other links on the website. This will make more room for administration announcements.

## Leave of Absence for Anthony Riggs - Firefighter

Mr. Jarrett read a letter from Firefighter Anthony Riggs requesting a leave of absence from the Fire Department, due to a personal situation, until the month of July, 2014. Chief Crumley approved the leave of absence.

Mr. Todd motioned to approve the six (6) month leave of absence for Anthony Riggs. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

## ODOT Open House regarding the Route 42 Widening

Mr. Jarrett said ODOT will be holding an open house Tuesday, March 4, 2014, at Medina City Fire Station #1 300 W. Reagan Parkway in Medina from 5:00 to 8:00 pm. This is regarding the road widening project on Route 42 which is approximately 650 feet south of Harding Street to a point, 962 feet south of Fenn Road. Mr. Todd suggested sending a letter to ODOT asking them to consider including a multi-use path in their plans.

#### PUBLIC COMMENT

Mr. Todd motioned to open the floor for public comment. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Jim Traynor (4004 Remsen Road) said he was glad public comment was on the agenda again. Mr. Todd said public comment was not discontinued permanently but just for one (1) meeting and that was explained to Mr. Traynor. Mr. Todd wanted it clarified that all three (3) Trustees were in agreement in postponing public comment for that meeting.

Bill Ostmann (3670 Hamilton Road) said the Comprehensive Plan Public Open House was a success. 66 people attended and a lot of new faces were there. The next Steering Committee meeting will be the last Monday in the month of March.

Sally Gardner (3333 Foskett Road) was told Mrs. Rosselli said that was the best attendance she had ever seen at one of those meetings.

Anthony Ratajczak (4430 Nettleton Road) discussed the issue of multi-use paths on Route 18 and Route 42. He presented Trustees with the documents regarding the ODOT meeting held February 6, 2014.

Mr. DeMichael said the Trustees were not informed of the meeting on February 6. He contacted the city and got a contact name for ODOT. He will talk to ODOT representatives when he attends the March 4 ODOT meeting regarding Route 42. Mr. Jarrett asked if there were any design plans for the southside and Mr. Ratajczak said no. Mr. Todd said we should be advocating for multi-use plans.

SUBJECT: New Emergency Research Study/PAMPer

As one of the busiest Level 1 Trauma Centers in the nation, with more than 3,000 admissions related to trauma each year, MetroHealth Medical Center, in conjunction with Case Western Reserve University, has been selected to conduct a research study that involves emergency treatment after a trauma when there is no time to obtain consent from the patient. The research study is titled "Prehospital Air Medical Plasma Trial," or "PAMPer", and is a four-year study sponsored by the U.S. Department of Defense. MetroHealth Medical Center and Case Western Reserve University are one of only six centers in the U.S. chosen to participate in this project.

The PAMPer study will help medical professionals learn more about trauma patients' care during air medical (i.e., Metro Life Flight) transport. The current standard of care for trauma patients who have hemorrhagic shock (excess bleeding causing less blood flow to organs) is an intravenous infusion of two units of AB plasma, the universal donor plasma, given upon arrival in the Emergency Department. This project will look at changing the standard of care by giving plasma pre-hospital during air medical (i.e., Metro Life Flight) transport.

This study will be conducted under an exception from the requirement for Informed Consent for Emergency Research because patients who are in extreme (life-threatening bleeding and shock) situations will be enrolled, and the treatment will be started in the helicopter en route to MetroHealth Medical Center. We will need to educate the community about the study so that individuals can decide whether they want to participate or opt out.

In an effort to inform and educate as many residents in Northeast Ohio of this clinical trial so they can decide if they would like to participate or opt out, I am asking that you mention this trial at your next community or town hall meeting, or in your next newsletter.
