RECORD OF PROCEEDINGS MEDINA TOWNSHIP TRUSTEES REGULAR MEETING APRIL10th, 2014

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on April 10th, 2014, to conduct the business of the Township. Chairman Todd called the meeting to order at 7:01 pm with the following Trustees in attendance: Michael D. Todd, Ken DeMichael and Ray Jarrett. Also in attendance were Fiscal Officer DeHoff, Police Chief Arbogast, Fire Lieutenant Schmitt, Road Foreman Miller, Zoning Inspector Ridgley and the general public.

Roll Call

Mr. Todd asked for a roll call of all members present. Trustees present were Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Pledge

Mr. Todd led the Pledge of Allegiance.

Moment of Silence

Mr. Todd asked for a moment of silence for our military personnel at home and overseas and to remember the Franklin Regional High School students near Pittsburgh, Pennsylvania.

OTHER BUSINESS

Approval of Accounts Payable

Mr. Todd motioned to approve warrant #25085 to #25122 in the total amount of \$33,586.79. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Approval of Payroll

Mr. Todd motioned to approve payroll checks #18515 to #18569 total of \$44,482.46 with \$6,909.08 payable to Post Tax Health, OPERS, Deferred Comp and union dues. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Approval of Minutes

Mr. Todd motioned to approve the February 27, 2014, regular meeting, the February 28, 2014, budget workshop meeting, March 13, 2014, regular meeting, and March 20, 2014, public hearing continuance. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Mr. DeMichael motioned to accept the March 27, 2014, regular Trustee meeting minutes. Mr. Jarrett seconded the motion. Roll call vote: Mr. DeMichael aye, Mr. Jarrett aye and Mr. Todd abstain.

OLD BUSINESS

Selection of Contractor for New Police Department

Mr. Todd told Chief Arbogast that Denny Miller spoke to Chris Jakab about the bids for contracting out the new police department renovation. Mr. Miller was told it needs an engineer's estimate before a contractor can be selected. Mr. Todd read the document given to him by Mr. Jarrett and stated that a lot of times there are exceptions to the rules and this just glosses over it. Mr. Todd said a decision cannot be made at this time and asked that a letter be sent to Asst. Prosecutor Tom Karris asking for an opinion. Mr. Jarrett asked if we have to go through the bid process all over again. Mr. Todd said the way it is worded it doesn't say it has to be part of the bid process but it has to be part of the project.

Electric Bill Discussion

Mr. Todd received an e-mail from the gentleman involved with the electric bill discussion and will ask him to attend the next Trustees meeting.

OLD BUSINESS CON'T

Remsen Building Roof

Mr. Todd tabled the discussion of the Remsen Building Roof.

Streetlight at Intersection of Rivendale and Fenn Roads

Mr. Todd tabled the streetlight at Rivendale and Fenn Roads until the Homeowners Association reviews the price given to Mr. Miller from Ohio Edison.

Building Department Services with Medina City

Mr. Todd said Trustees received a legal opinion stating that legally we cannot use the Medina City Building Department. A letter will be sent to Mayor Hanwell.

Vending Machines at Blakslee Park

Bryon Paterak of Triple Crown Vending asked for the Trustees approval to install a beverage only vending machine at Blakslee Park. He stated it would not cost the Township any money. He would take care of the equipment and everything involved with the machine. His phone number will be on the machine for people to reach him in case of lost money or malfunction of the machine. If the machine is vandalized he would be responsible for repair and he would pull the machine if it gets vandalized a second time. He is fully insured. Mr. Todd said to send a letter to the Prosecutors Office asking for an opinion on this matter.

PURCHASE ORDERS AND TRAINING REQUESTS

Icandi T-Shirts - Pick-it-up-Day

Mr. Todd motioned for the expenditure of \$423.00 payable to Icandi Graphics for t-shirts for Pick-it-up Day. They are \$4.70 apiece. The money actually comes from Community Partners which are donations given to the Township for these types of programs so it doesn't come out of tax money. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Police Department Body Armor Vests - Super Blanket

Mr. Todd motioned for a super blanket purchase order for seven (7) body armor vests in the amount of \$1,000.00 apiece for a total of \$7,000.00. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Grant for SWAT Vehicle Received

Mr. Todd explained that a grant for a SWAT vehicle was received. The vehicle cost was \$800,000.00. It did not cost the Township anything and we do have an Officer on the SWAT team. The vehicle is used for active shooters situations. The vehicle is located in Texas and the Sherriff is asking for people in the community to contribute in the return of the vehicle to Medina County. He is asking for \$500.00 from Medina Township. Mr. Jarrett asked if he will get money from all seventeen (17) Townships, where will it be stored and who will pay for maintenance of the vehicle. Chief Arbogast said it is all part of the Sheriff's Department. He also said we have used the SWAT team twice for a hostage situation and a standoff. Mr. Jarrett asked if we would have part ownership in it. Mr. Todd said no, we are not setting a precedent. Mr. DeMichael said it is great to have access to that type of vehicle and he is fine with it. Chief Arbogast said they only gave out five (5) vehicles and the Sheriff was surprised to get one.

Mr. Todd motioned to approve the expenditure for \$500.00 to pick up the MRAP that was subject to a law enforcement grant that's owned, operated and maintained by the Medina County Sheriff's Department and that this is a one-time donation to assist in transportation of the vehicle to Medina County. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Mr. Jarrett said training requests must be given to the Trustees 24 hours beforehand.

REPORTS/DEPARMENT HEAD COMMENTS

Zoning Department

Mrs. Ridgley gave the Trustees an update on the Windfall project. She completed Gateway Drive and Mackensey Circle. She said out of sixty (60) homes only fourteen (14) were okay. Twenty-four (24) would have to have the structure removed and they need permits and the other twenty-two (22) need permits. All 46 need permits. Mr. Todd suggested working on the twenty-two (22) that need permits and she said she would like to finish going through all of Windfall.

Mrs. Ridgley read her report for March 2014, stating 20 permits were issued for a value of \$1,415,840.00 (see attached).

Police Report

Chief Arbogast reported that the department responded to 743 calls for service in February 2014. The department responded to 865 calls for service in March 2014. There have been some very expensive rims stolen from car dealers and they also had the shooting incident. The shooter was indicted for attempted aggravated murder and the other suspect was charged with obstruction and tampering with evidence. The victim is still in critical condition.

Mr. Todd motioned to approve the March 2014, zoning report, the February and March 2014 Police Department report. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett.

Weymouth Preservation Society Report

Mrs. Gardner reported that the open house will be this Sunday (April 13) from 2 to 4 and the display will include information regarding the school itself that includes the timeline of the teachers that taught there. Also there will be displays on the Weymouth Church, the basket factory and the Becker gas station. The plant sale will be May 10, from 10am to 1 pm.

PUBLIC COMMENT

Mr. Todd motioned to open the floor for public comment. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Sally Gardner (3333 Foskett Road) stated that a friend was unable to get a title transfer for a home that she had purchased with an existing shed because there was no permit on the shed. She had to get a permit.

Jim Apana (3993 Dogleg Trail) said he is very happy to see the relaxed atmosphere return to these meetings.

Dianna Huffman (4025 Remsen Road) said the homeowners pay for the title search but it's not being done.

Laurie Shoemaker, Special Project Coordinator, reminded everyone of Toss your Trash Day on April 12 and Community Pick- it- up Day on April 19. She also reminded everyone of the Flag Day Ceremony on June 14 starting at 4:00 pm. The ceremony has been shortened. The Community Band will not be available but after the ceremony there will be a "Harlem Globetrotter" type of baseball game put on by the Hollywood Diamond Jesters. Tickets will be sold for the game. There will be concessions, contests, prizes, 50/50 and more. Mr. Todd hopes the change will bring in more people and they made it more of a family event. They also have the 4th grade essay contest on what the flag means to them to get children involved in the patriotism of the flag. Mr. DeMichael said Key Club will be sending students to help on pick it up day.

Gary Vene (3783 Hamilton Road) said they had a federal grant where he worked in Cuyahoga County for MRAP vehicles and the subdivision where the vehicle resides is responsible for the maintenance of the vehicle. Mr. Todd said it will reside with the Sheriff's Office and he will be responsible for maintaining the MRAP.

Chief Arbogast said on April 11 the first Criminal Interdiction Task Force will be on 171 and other areas off the interstate. They will have five (5) different agencies with twelve (12) Officers out. This is a collaborative thing with the Sheriff which gives us countywide jurisdiction similar to the DUI Task Force. There will be three (3) teams and each team will have a canine to reduce drugs and criminal activity that is going through Medina County. Everyone that is involved in this has been specially trained. They know what they are looking for.

Mr. Todd asked Mr. Ostmann if the Steering Committee is wrapping up and Mr. Ostmann said yes. He is waiting to hear from Ms. Rosselli to see if any of the committee members made any changes to the final draft. The deadline is tomorrow at noon (4/11). If there are changes that have to be voted on then they will have to have another meeting.

Mr. Todd motioned to close the floor for public comment. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Todd, Mr. Jarrett and Mr. DeMichael.

Executive Session to Discuss Employee Discipline

Mr. Todd motioned to go into Exceptive Session with Lieutenant Schmitt and the Medina Township Board of Trustees to discuss employee discipline. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett. The Board entered into Executive Session at 7:51 pm.

Mr. Todd motioned for the Board of Trustees to reconvene from Executive Session where we were present with Lieutenant Schmitt discussing employee discipline. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Todd, Mr. DeMichael and Mr. Jarrett. The Board reconvened at 8:10 pm. No decisions were made during that meeting.


