Also in attendance were the Fiscal Officer, Police Chief, Fire Chief, Road Foreman, Zoning Inspector and the general public.

### Roll Call

Mr. DeMichael asked for a roll call of all members present. Trustees present were Mr. DeMichael, Mr. Jarrett and Mr. Ostmann.

# Sola Salon - Wall Sign "A" - 5050 Victor Drive

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the wall sign for Sola Salon at 5050 Victor Drive not to exceed 45 total square feet as presented. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Jarrett and Mr. Ostmann.

# Sola Salon - Wall Sign "B" -5050 Victor Drive

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and deny a second wall sign for Sola Salon at 5050 Victor Drive as it does not comply with Section 605.1 of our zoning code, as presented. Mr. Ostmann seconded the motion. Brett Smith, applicant, stated that the Zoning Board of Appeals approved 20 feet on the east side and 30 feet on the southside. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett.

# True North Shell - Site - 3131 Medina Road

Rick Turner, representative for True North Energy, asked for clarification on the denial by the Zoning Commission for new construction. Is it based on the setbacks only or is it to deny the idea of doing construction. Mrs. Strogin, Zoning Commission Chairperson, said it was merely to deny the site for construction because it did not meet the setback requirements. It will go to the Zoning Board of Appeals for a variance.

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and deny a request for new construction for True North Shell at 3131 Medina Road as the building and canopy fail to meet front and side yard setbacks, as presented. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Jarrett and Mr. Ostmann.

### True North Shell - Wall Sign - 3131 Medina Road

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve a request for a wall sign for the principle structure located at 3131 Medina Road not to exceed 41 square feet as presented, contingent upon the Zoning Board of Appeals approving the variance for new construction. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett.

# True North Shell - Two (2) Ground Signs - 3131 Medina Road

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the request for two (2) ground signs for True North Shell located at 3131 Medina Road not to exceed 32 square feet each as presented, contingent upon the Zoning Board of Appeals approving the variances for new construction. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Jarrett and Mr. Ostmann.

### True North Shell - Two (2) Canopies - 3131 Medina Road

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and deny a request for two (2) canopies, 16 square feet each, as they do not comply with Medina Township's Zoning regulations. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett.

# Health Care Plan

### Resolution No. 01022015-003

Mr. DeMichael motioned to put forth the following resolution for a health care plan: A health care plan will be offered to full-time employees, with employees responsible for 15% of premiums for medical, dental and vision insurance, deductibles and co-pays excluding those covered under the collective bargaining agreement. Part-time employees are also offered medical and dental plans where they will be responsible for 100% of their premium. It should be noted that part-time employees are not eligible for health care savings account reimbursements. Full-time employees that choose or opt-into the health care plan will be reimbursed with their health care savings account in the same terms as offered to the Police Officers in the collective bargaining agreement.

# Township Secretary/Assistant Fiscal Officer

The Township Secretary/Assistant Fiscal Officer will be paid \$16.94 per hour plus full-time employee benefits.

# Part-time Office Assistant

Part-time Office Assistant not to exceed 25 hours per week, not to include benefits, at \$11.00 per hour.

### Special Project Coordinator

Special projects coordinator will be paid \$27,268.80 per year plus full-time employee benefits.

### Zoning Inspector

Zoning Inspector will be paid \$17.47 per hour plus full-time employee benefits. Zoning Office Hours will be 9:00 am to 4 pm Monday through Friday.

# **Zoning Commission Members**

Zoning Commission members will be paid \$40.00 per meeting attended and pre-approved workshops attended.

### Zoning Board of Appeals Members

Zoning Board of Appeals Members will be paid \$40.00 per meeting attended and pre-approved workshops attended

### Alternates to Zoning Board and Zoning Board of Appeals

Alternates to the Zoning Board and Zoning Board of Appeals will be paid \$40.00 per meeting attended and pre-approved workshops attended.

# Chairpersons of the Zoning Board

Chairperson of the Zoning Board will be paid \$40.00 per meeting for attending Trustees meeting where site plans are considered, County Planning Commission meetings where zoning issues within the boundaries of Medina Township are under consideration and for attending the Zoning Board of Appeals meetings (copy of agenda and sign in sheet to be submitted).

# Police Department

<u>Full-Time Chief of Police</u>: \$72,148.80 per year.

# Police Officers and Sergeants

Wage and benefit structure for the Police Department for 2015 will be per the negotiated contract in 2013.

# Part-time Police Officers

\$14.50 per hour. After 1 year of service the rate will be \$16.16 per hour. Education bonuses will be as follows: Associate's Degree \$1.00 per hour

BS/BA Degree \$1.50 per hour

Master Degree and above \$2.00 per hour

Compensation for uniform allowance will be approved by the Board of Trustees on a case by case basis.

### Receptionist/Clerk

Hours are Monday through Friday 9 a.m. to 2 p.m. at \$11.00 per hour with no benefits. That position is not to exceed 25 hours per week.

# Fire Department

# Part-time Fire Chief

\$30.59 per hour plus longevity based on approved Fire Department pay rate schedule as of 1/2/15 limited to 30 hours per week.

# Firefighter/Officer

Medina Township Firefighters/Officers pay scale (see document marked exhibit A). Personnel that are already at or over 5 years of service will receive a \$.36 cents per hour increase from their 2014 base pay.

Probationary Firefighters pay rate: State minimum wage of \$8.10 as of January 1, 2015.

Denny Miller Fire Department pay rate: \$24.55 per hour for fire calls.

Ed Kerr Fire Department pay rate: \$24.09 per hour for fire calls.

# Records Clerk (Part-Time Secretary)

Part-time Records Clerk (Secretary) shall be paid \$15.92 per hour.

### Service Department Sick Hours & Comp Hours

Road Department is entitled to accumulate sick leave at 4.6 hours for every eighty (80) hours of service per pay period or forty (40) hours per week. Comp hours are capped at eighty (80) hours. At the point that compensatory time exceeds eighty (80) hours, it must be taken as paid compensation. Accrued compensatory time may be carried through to the next calendar year, not to exceed eighty (80) hours. Sick time is not to be accrued on overtime hours or when comp time is paid.

# Clothing Allowance for Full-time Service/Park Department Employees

Clothing allowance for full time Service/Park Department employees is \$500.00 per year.

# **Longevity Pay**

Not-withstanding the collective bargaining agreement, longevity pay is to be paid to full-time employees only, after their third year of employment, at \$100 per year with a cap of 15 years of service.

# **Sports Fields Fees**

The charge is \$50.00 per time slot (3-hours) for Medina County Residents and \$60.00 per time slot (3-hours) for organizations that reside outside of Medina County. Soccer Field charge is \$17.50 per hour.

# Zoning Fees

The Zoning Fees will be pursuant to the Appendix V (five) of the Medina Township Zoning Resolution.

# Mileage

Mileage for use of personal vehicles on Township business will be paid to the prevailing IRS rate for 2015.
