#### RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING FEBRUARY 9<sup>TH</sup>, 2017 7:00 PM

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on February 9<sup>th</sup>, 2017, to conduct the business of the Township. Chairman Ostmann called the meeting to order at 7:00 pm with the following Trustees in attendance: Bill Ostmann, Ray Jarrett and Ken DeMichael. Also in attendance were the Fiscal Officer, Police Chief, Fire Chief, Road Superintendent and the general public.

#### Roll Call

Mr. Ostmann asked for a roll call of all members present. Trustees present were Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

#### **Pledge**

Mr. Ostmann led the Pledge of Allegiance.

#### **Moment of Silence**

Mr. Ostmann asked for a moment of silence for our service members both here and abroad and for our first responders who are risking their lives every day to keep us safe.

#### **Kevin Brect of Mobilitie**

Mr. Brect did not attend the meeting.

#### **Approval of Supplemental Appropriations**

Mr. Ostmann motioned to approve the supplemental appropriations for 2/1/2017through 2/28/2017. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### Then and Now Purchase Orders

Mr. Ostmann motioned to approve the following purchase orders:

The vendor is Cintas Corp and the amount is \$83.08 and it is for a blue mat.

Next, the vendor is ComDoc, Inc., it is for copier overage charges and the amount is \$5.68.

Next we have Intech Computer Solutions and it is for annual billing, 2016, off site data backup and the amount is \$1,198.00.

Next we have CMT Group and this is for car washes and the amount is \$37.50.

Next the vendor is VASU Communications and it is for the SING Unit Tri Chemistry Rapid Charger and the amount of that is \$49.00. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Mr. Ostmann motioned to approve the January bank reconciliation and this is three (3) pages long and I will incorporate it by reference. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Mr. Ostmann motioned to approve accounts payable checks #27949 through #27989. Total amount is \$108,990.59. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Mr. Ostmann motioned to approve accounts payable checks #27990 through #28018. The total amount on that is \$49,763.48. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### **Approval of Payroll Checks**

Mr. Ostmann motioned to approve payroll checks #22660 through #22934. Total amount of \$51,798.71 with \$6,397.38 withheld for taxes, union dues, OPERS, etc. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

#### Approval of Payroll Con't

Mr. Ostmann motioned to approve payroll checks #22735 through #22790. Total amount, \$50,109.71 with \$7,281.07 withheld for taxes, union dues, OPERS, etc. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### **Approval of Minutes**

Mr. Ostmann motioned to approve the January 3 minutes for the organizational meeting and the January 12 minutes for the regular meeting. Mr. DeMichael seconded the motion. Mr. DeMichael wanted to be sure Susan McKiernan's comment of "what good are you people" was in the minutes. He felt it was insulting especially because of all the things the Trustees do for them, you know, the Weymouth Preservation Society. Mr. DeMichael said he thinks it's a shame because there are a lot of other communities, smaller communities within our community that would probably be grateful for all the things that we've done for them. Mr. DeMichael said, to make matters worse we got an apology e-mail, and this is a matter of public record as well, stating she apologized for saying that but then went on to say we weren't doing our jobs correctly, is how I took it, and I kind of took offense to that. I think Susan should probably run for Trustee, if not this next time around run against me a few years from now. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### **Approval of Department Reports**

Mr. Ostmann motioned to approve all the departmental reports for December and January. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

#### **PURCHASE ORDERS AND TRAINING REQUESTS**

#### 2017 Northern Ohio Arson Seminar

Mr. Jarrett motioned to approve a requisition in the amount of \$110.00. This is for Gary Bromley to attend the Co-Ed for County Task Force and Arson for February 25, 26 of 2017 at Ashland University. Mr. Ostmann seconded the motion. Chief Crumley said Gary Bromley is on the Medina County Arson Task Force and this is the continuing education seminar. Voting aye thereon: Mr. Jarrett, Mr. Ostmann and Mr. DeMichael.

#### Medina County Technical Rescue Operations Team

Mr. Jarrett motioned for a purchase order requisition in the amount of \$1,746.57. This if for the Fire Department and the vendor information is the Medina County TRT out of Medina, Ohio, and this is for the 2017, Technical Rescue Operations Team allocation. Mr. Ostmann seconded the motion. Chief Crumley said technical rescue is specialized in the industry and the State and County go together to make it more affordable for all departments. Voting aye thereon: Mr. Jarrett, Mr. Ostmann and Mr. DeMichael.

#### Across the Street Productions - Fire Department

Mr. Jarrett motioned for a purchase order requisition for the Fire Department in the amount of \$2,504.00. Vendor information is Across the Street Productions out of South Bend, Indiana and this is for the annual instructor renewal and student renewal fees. Mr. Ostmann seconded the motion. Chief Crumley said it is for himself, his officers and crew leaders for Blue Card training for commanding operations on calls. He said they receive a \$626.00 discount on this price. Voting aye thereon: Mr. Jarrett, Mr. Ostmann, Mr. DeMichael.

#### Blanket Purchase Order for Uniforms for the Police Department

Mr. Ostmann motioned to approve a purchase order requisition and the vendor information; this is a blanket for uniforms. The department is Police. This is for uniforms and bullet proof vests and the amount is \$8,000.00. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

#### Pro-Tech - Bullet Proof Vests - Police Department

Mr. Ostmann motioned to approve a purchase order requisition. The vendor information is Pro-Tech and the department is Police and this is for three (3) each and these are ballistic vests and they are per the labor contract and the total amount on those is \$2,635.26. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### PURCHASE ORDERS AND TRAINING REQUESTS CON'T

#### Costco - Camera System - Admin

Mr. Ostmann motioned to approve a purchase order requisition. The vendor information is Costco and the description is a camera system and a brief explanation. After what occurred in Lafayette Township we decided that we should put some cameras in here to see who is coming and going. The total amount on that is \$1,727.99. The department is Admin. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

#### Ohio Chief's Conference - Sgt. Zieja

Mr. Ostmann motioned to appropriate \$775.00 for a conference, the Ohio Chief's Conference. It is for professional development and required training for Sgt. Zieja. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

#### Sirchie Forensic - Officer Mike Oyler

Mr. Ostmann motioned to appropriate \$400.00 and this is for a conference, Sirchie Forensic. This is for Mike Oyler and this is for crime scene processing. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### **DEPARTMENT HEAD COMMENTS**

#### Fire Department

Chief Crumley thanked Trustees for approving the requisitions and things. Chief Crumley said he understands the Trustees talked to the Mayor (Hanwell) because that is one of the things they wanted to do and he was hoping to set up a workshop regarding the new Fire Station for next Thursday (February 16) if possible and if it is good for everybody. Mr. Jarrett asked Mr. DeMichael and Mr. Ostmann if they met with the Mayor (Hanwell) and they said yes. Mr. Jarrett said there will be no discussion regarding their meeting with the Mayor at the workshop if you understand that because we have not proceeded past our first meeting. The time will be 7:00 pm. The workshop meeting regarding a new Fire Department will be advertised.

#### **Road Department**

Superintendent Miller said the restroom/concession stand project is coming along. The rough plumbing was finished today and the electrical should be done the first part of next week.

#### **NEW BUSINESS**

#### **SPCA Donation Request**

Mr. Ostmann said a letter was received from the SPCA asking for a donation to help defray the cost for the care of the thirty-four (34) animals that were rescued. The amount was \$8,079.18. Mr. DeMichael asked what was paid last year and was told \$1,280.00. Mr. Jarrett asked if the addresses were verified and was told yes. Mr. Jarrett said this year's amount of animals rescued decreased from last year. The Trustees tabled this item until the next meeting. The Secretary will send them the previous year's information.

#### Approval of January 28, 2017, Supplemental Appropriations

Mr. Ostmann motioned to approve the January Supplemental Appropriations. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett. Mrs. Ventura said this was all the changes that were made at the last meeting. Mary Beth. Guenther needed it in a nice little spread sheet.

#### Approval of Appropriation Status as of January 28, 2017

Mr. Ostmann motioned to approve the appropriation status as of 1/28/2017. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### **NEW BUSINESS CON'T**

#### Certificate of the Total Amount From all Sources Available for Expenditures & Balances

Mr. Ostmann motioned to approve the Certificate of the Total Amount From all Sources Available for Expenditures & Balances and this is a two (2) page document and I will incorporate this by reference. Mr. DeMichael seconded the motion. Mrs. Ventura said that that may change by about \$1,000.00. She e-mailed Mary Beth but she is on vacation so one purchase order was able to be shut out for 2016 so we actually have a little bit more money but I don't know if it is too late to get it to her so if it was then that just won't be freed up until 2018 but you may have to re-sign something. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### Approval of Medina Township Inventory

Mr. Ostmann motioned to approve the Medina Township Inventory for 2016. It is a total of thirteen (13) pages and the total amount is \$3,951,055.60. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

#### Linda DeHoff Letter of Resignation

Mr. Ostmann read the letter of resignation from Linda DeHoff (see attached). Mr. Jarrett said a letter was received from the Prosecutor's Office regarding an inquiry into Linda DeHoffs operations as Township Administrator. Mr. Jarrett said our Fiscal Officer made that inquiry regarding the OPERS contribution and the Bureau of Workers Compensation premiums. The Prosecutor's summary stated that the OPERS Contributions and the Workers Compensation premiums paid by the Administrator appear to be legitimate obligations of the Township. The actions of the Administrator reflect a lack of communication but do not in our view constitute a violation of law. Mr. Jarrett said so there is no violation. Mrs. Ventura asked that he read the rest of the letter. Mr. Jarrett continued saying, for future reference, be advised the Fiscal Officer is invested by statute with responsibility for the finances of the Township. Any and all information that comes to the Township relevant to that function must be forwarded to the Fiscal Officer's attention and no financial transactions should be carried out without the Fiscal Officer's authorization. We hope for and strongly encourage a cooperative and transparent relationship among individuals serving Medina Township. Mrs. Ventura said she just wanted to present this and you guys can go over it at your leisure. These are the last four (4) audits. Clean bill of health is not the words that, well first of all they would never say that and basically they have findings, every single audit there were findings, they mean there were problems. I don't want to pick on anyone because they're there to make us do better work so they look for things but to say that there was a clean bill of health and that her audits always came back... they didn't. Mr. Ostmann asked if she was going to leave the documents where Trustees can review them and she said yes and she had highlighted each of them.

#### 2017 Budget Workshop

Mr. Ostmann asked Mrs. Ventura when she wanted to hold the budget workshops and if she wanted one (1) or two (2) workshops. Mrs. Ventura said she was fine with one (1) because she is going to meet with each department head and go over their budget requests. She also asked if Trustees wanted to wait until they got the final certificate back from Mary Beth or did they just want to go on. Mrs. Ventura said we might as well just meet because Mary Beth is not going to change much but, it's up to you guys. Mr. Ostmann said that is fine and Mr. Jarrett said whatever you want to pick. Mrs. Ventura said they won't have the certificate back. The budget meeting is the third Friday of the month so we won't be getting that certificate until the week of the 20<sup>th</sup> or later and she feels it is better to get it done sooner than later. She said the temporary appropriations take us through March 31 so we are not in a hurry to do this. Also, the Bureau of Workers Comp has a new program and why we had to make the payment in January. We have to do something call Tru-Up by the 15<sup>th</sup> where we have to report to them what our total annual salaries were last year and we may end up owing them money at that point if it is not correct and we don't have any money in the BWC lines. Mr. Jarrett said that could be appropriated before you ask the department heads to submit their wish lists and he would like to see their lists before the budget workshop. The Trustees and Fiscal Officer set the Budget Workshop for February 27, 2017, at 5:00 pm.

#### **PUBLIC COMMENT**

Mr. Ostmann motioned to open the floor for public comment. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Susan McKiernan (3306 Old Weymouth Road) said the Weymouth Preservation Society has a new web page under Weymouth Preservation Society.com. There will be a tea fundraiser at the end of April. The vinyl accordion doors will be replaced with old fashioned wooden ones. We are members of the Northeastern Ohio Inter-Museum Council, the Historical Council in Medina County and a local history alliance with the State. The next exhibit will be boys and girls toys from 1820 to 1900. Bicentennial projects for the Township include historic homes plaques. We will have a cemetery tour in the fall and a potluck. Weymouth Ohio has a facebook page. There have been good comments regarding the restroom/concession at Blakslee Park. She asked the status of the Rita Holt Park since the sign is gone. Mr. Ostmann said they do not have any funds to create a park. There are conservation easements on it right now. Mr. Miller said he thought it was leased to the County and they were going to make it into a park.

Mark Radice (4036 Stonegate Dr.) asked the status of the sale of the school. Mr. Ostmann said it is in the hands of the attorneys and the finalization is close.

Jim Traynor (4004 Remsen Rd.) congratulated the Board for hiring Bill Thorne as an attorney for the Township especially for the Zoning Commission because questions can be answered the same evening. He also thanked Susan McKiernan for all the work she has done to preserve the history of the Township.

Matt Galla (3503 Hamilton Rd.) asked why \$30,000.00 was spent for an architect for the Fire Department. Mr. Jarrett said it was for a shovel ready site plan and an overview of what the building was going to look like. Mr. Galla asked if they are planning on building that \$3 million dollar station. Mr. Jarrett said the Board has not determined that yet. Mr. Galla asked what the \$8,000.00 for drilling was for. Mr. Jarrett said the drilling was for an offsite location in case the other location does not work. Mrs. Ventura said the amount for the drilling was only \$4,000.00. Mr. Galla asked if they plan on moving the current fire station. Mr. Jarrett said a determination has not been made by the Board and they are in negotiations with other entities regarding collaboration and that cannot be discussed publicly. Mr. Galla asked if we have a levy for this and was told the Board has not determined financing or any levies yet. Mr. Galla does not feel there is a need for a \$3 million dollar Fire Station or a levy. Mr. Galla asked why they bought a new engine to replace an old one, used it as a backup and then sold it to Litchfield Township. Chief Crumley said we replaced the engine and used the old one for reserve in case the truck breaks down. The truck sold to Litchfield was a tanker. We take care of our vehicles.

Mark Radice (4036 Stonegate) asked Mr. Galla what happens when a semi breaks down on the highway. Mr. Galla said you would call for repair. Mr. Radice asked what you do if a fire truck breaks down during a fire.

Gary Vene (3803 Hamilton Rd.) said Fire Departments don't just handle fires, they do Haz-mat, ems, technical rescue. A Fire Department is called upon to do many things. He also asked if Linda DeHoff had a pattern of making mistakes or was it just one time. Mr. Ostmann said as far as he knows, no. They will review the audits. Mr. Vene asked what they are looking for in the soil samples they are taking, is it for a one (1) story or two (2) story building.

Mark Roberts (3496 Old Weymouth Rd.) stated he was at the station today and they completed their fifty ninth (59) calls for service. When residents dial 911 they expect service. Mr. Roberts said they also spent five hours today doing maintenance on broken trucks.

Robin Gray (4074 Remsen Road) asked if our Fire Department responds to calls outside of the Township. Mr. Ostmann said yes when mutual aid is asked for. She asked how often that happens and Chief Crumley said it happens a couple times a month and stated that we also ask for mutual aid when we need them. She asked if the supplies and labor for the mutual aid come out of our Fire and Police funds. Mr. Ostmann said yes and when we use them they reciprocate. She asked if our taxes are being used for other Townships. Chief Crumley said no, he doesn't think they have been on a mutual aid call more than three (3) hours.

#### **PUBLIC COMMENT CON'T**

Robin Gray (4074 Remsen Road) asked if they think that all these new Fire Departments being built in the county are because they are bringing the Nexus pipeline through our community for the industrialization of the county. Chief Crumley said no, the building of new stations in the county is to replace old stations. She said it is our property taxes that are paying for this.

Mark Radice (4036 Stonegate Dr.) said we all can agree, as the Fire Department we just want it to go to the voters, educate people and let them decide. We're not asking for anyone to sign off on something they are not comfortable with but we're asking for the chance.

Robin Gray (4074 Remsen Road) feels it is wrong for Trustees to come out of Executive Session and make payments when there is no audience left in attendance to hear about the payments. Mr. Jarrett said they do purchase orders in the middle of the meeting. Ms. Gray and Mr. Galla said they want them to be transparent when they approve purchase orders. Mr. DeMichael said that was because they had an Executive Session to discuss the contract, which we did, and when we came out of Executive Session is when we can make that decision. He said if you like Trustees can have public comment after Executive Sessions and we can approve any big expenditure at the next Trustees meeting if it is not time sensitive. The issue was that a bill came in as part of that service and they needed to approve it so it wouldn't be a then and now. Mrs. Ventura said the money was appropriated it just needed a purchase order opened. Ms. Gray said she is disappointed about how this has come about. It (fire station) is going to be a 19,000 square foot building, it is huge, and we taxpayers are going to have to pay for all this plus the people in it and it is a lot of future expense. She asked why the Mayor is involved in this. Mr. Jarrett said they are looking into all options to get the biggest bang for the services and I will protect the taxes as much as I can. He said the citizens will make the decision on that.

Gary Vene (3803 Hamilton Road) said Trustees should consider that sometimes the lowest cost is not the best cost. We should leave the community better than it was.

Mark Radice (4036 Stonegate Dr.) wanted to clarify that the Trustees approved the hiring of an Architect at a public meeting, it was never done behind closed doors. The \$30,000.00 was a payment that was coming at some point. He said the only thing Trustees did in Executive Session was discuss how they were going to appropriate those funds. Mr. Radice asked if Trustees ever had another group in the Township provide as much background as the Fire Department has done. Mr. Jarrett said they did their due diligence and he thanked the Finance Committee for meeting with the Fire Department and giving the Trustees an informed decision regarding other options. Mr. Jarrett said Trustees are looking at multiple operations, EMS and fire based and the Board has not made any determinations. Mr. Radice went on the record stating how much work the Fire Department has done for the last ten years on this project. Mr. Jarrett said the Board of Trustees did not rubberstamp the Finance Committee options and Trustees want to protect the taxpayer's money.

Matt Galla (3503 Hamilton Rd.) asked who was on the finance committee. Chief Crumley said it was Kay Kubusta, Bill West, Karen Fischer and Brigitte Painter. Chief Crumley said they had to educate them about the fire service because they had no clue about the fire service and they also wanted a committee that would ask hard questions.

Mr. Ostmann motioned to close the floor for public comment. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### **Executive Session to Discuss Employee Discipline**

Mr. Jarrett motioned to go into Executive Session with the three (3) Trustees and the Fire Chief to discuss employee discipline. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. Jarrett, Mr. Ostmann and Mr. DeMichael. The Board entered into Executive Session at 8:29 pm. The Board reconvened at 8:42 pm. No decisions were made in Executive Session.

#### Ian Shirey Reactivated from Administrative Leave

Mr. Jarrett motioned to install Ian Shirey back to active duty status from Administrative leave that we placed him on back in 2016. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. Jarrett, Mr. Ostmann and Mr. DeMichael

#### **Executive Session for Employee Compensation**

Mr. Ostmann motioned to enter into Executive Session with the full Board of Trustees, the Fiscal Officer to discuss employee compensation. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett. The Board entered into Executive Session at 8:45 pm. The Board reconvened at 9:30 pm. No decisions were made in Executive Session.

#### Road Department Laborer - Craig Plute - Raise

Mr. DeMichael motioned that we raise Craig Plute's pay from \$18.03 to \$20.03. He's over his probationary period and has done a great job for us so far, effective February 19, 2017. Mr. Ostmann seconded the motion. Mr. Jarrett asked Mrs. Ventura if that will fit into her payroll schedule and she said yes. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett.

#### **Executive Session to Discuss Employee Compensation**

Mr. DeMichael motioned to enter into Executive Session with the three Trustees, Fiscal Officer and Road Foreman Denny Miller to discuss employee compensation. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett. The Board entered into Executive Session at 9:31 pm. The Board reconvened at 10:39 pm. No decisions were made during that meeting.

#### Rescinding of Motion for Craig Plute Pay Raise

Mr. DeMichael motioned to rescind my last motion before the Executive Session. Mr. Ostmann rescinded his second. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett.

#### Craig Plute Pay Raise and Title Change

Mr. DeMichael motioned to increase Craig Plute's rate of pay from \$18.03 to \$20.03 and change his title from laborer to working foreman and this is because his probationary period is over and he's done such a great job, effective February 19, 2017. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett.

#### **Executive Session to Discuss Land Acquisition**

Mr. Ostmann motioned to enter into Executive Session with the three (3) Trustees, the Fiscal Officer and Chief Crumley to discuss land acquisition. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael. The Board entered into Executive Session at 10:41 pm. The Board reconvened at 12:12 am Friday, February 10. No decisions were made during that meeting.

#### Amendment to the Hiring of Bill Thorne

Mr. Ostmann said he made a motion to hire Bill Thorne at the January 12 meeting and he would like to amend that motion where he said the one (1) year would be January 1 to December 31. Mr. Ostmann motioned to amend that it will be ten (10) months beginning March 1 through December 31. Mr. Jarrett seconded the motion. Roll call vote: Mr. Ostmann aye, Mr. Jarrett aye and Mr. DeMichael no.
