Chairman Ostmann called the meeting to order at 7:00 pm with the following Trustees in attendance: Bill Ostmann, Ray Jarrett and Ken DeMichael. Also in attendance were the Fiscal Officer, Asst. Fire Chief, Road Superintendent and the general public.

OTHER BUSINESS

Sale of Remsen Property

Mr. Ostmann said Richard Clark (3306 Old Weymouth Road) had a letter to read from the Weymouth Preservation Society (see attached). Mr. Clark said he was asked by the WPS to read this letter because the President and Vice-President are out of town.

Sale of Remsen Property Con't

Annette Davis, Superintendent of Medina County Board of Developmental Disabilities, explained the changes that were mandated by the Federal Centers for Medicaid and Medicaid Services. The law states that a public entity such as them could not provide services to individuals with developmental disabilities and provide targeted case management or SSA at the same time. All county boards in the State of Ohio were given a choice, of providing services and /or SSA or case management services. The State chose the SSA or case management function of the County Board because we are also the fiscal agent and in order to keep the fiscal responsibility we had to keep SSA and not service provision. She asked all private service providers to develop programs in which we could best serve the individuals in the community as per the new definition of CMS. It states that individuals should live and work in their community. She has asked Intervention for Peace to try to develop training programs for them to be able to work and play in their community which they have done with their SPOKES building. She said Windfall is not closing down they are just phasing out of two (2) service areas which is our adult services and transportation.

Dave Clardy (3497 Old Weymouth Road) has spoken with Tom Barko, Karen Fisher, Scott and Mike Kaminsky. Mr. Clardy proposed a compromise that the museum side of that building would remain the same, we would not use that but they would be using the storage area for offices so another location will be found for the artifacts storage. The middle section would remain a common area that they would use during the week for meetings, training and so forth. It will be a shared community room. Hours will be 8am to 4pm Monday thru Friday. The WPS would have access to the building just as they had all this time. Mr. Clardy stated we will only use temporary partition walls there, that we would be very careful with that area as well.

Mr. Ostmann spoke to the Mayor and a Montville Township Trustee who stated they were satisfied with what Mr. Clardy had done there. Mr. Ostmann asked if he was planning on having retail at Remsen because there is retail at the City and Montville locations. Mr. Clardy said no. Mr. Ostmann said having a coffee shop and renting bicycles is considered retail and is not allowed in that district. Mr. Clardy said absolutely not, it will not be retail. They need a bigger hub for training. The Soccer Association sent him an e-mail stating they would love to partner with Intervention for Peace for their concession on the weekends.

Mr. Jarrett asked what his specific intentions were for the use of that particular parcel. Mr. Clardy said the garage portion will be used for training. There is a trainer teaching public speaking and a dog trainer to teach proper handling of dogs and other types of programs as well as their administrative offices consisting of five (5) people. Soccer will remain. Mr. Jarrett asked if the dogs will be trained at that location 24/7 and Mr. Clardy said no. Mr. Jarrett asked what their hours of operation were and Mr. Clardy said office hours are 8am to 4 pm Monday through Friday. Program hours are 9am to 2:30 pm. Mr. DeMichael asked Mr. Clardy if he had someone to put a purchase agreement together and Mr. Clardy said yes. Mr. Jarrett said since we are back to square one again, he asked Mr. Clardy to work out some of the details with WPS where there is a happy compromise that works for both parties and then present it to the Board of Trustees. Mr. DeMichael asked Mr. Jarrett what hesitation could he come up with, with what he proposed this evening. Mr. Jarrett said he likes to see things in writing.

Richard Clark agrees with what Intervention for Peace does. He said the compromise is to keep the museum and share that one space and asked where all the archived files will be kept. He also praised Susan McKiernan for all her hard work in getting historical information for the Township and others. He said there are offices and a conference room in the back building. He asked if a compromise could be reached because that room is vital the WPS.

Tom Borror (3747 Watkins Road) said two (2) of the three (3) occupants of the building are interested in buying the building and Medina Creative Housing plans on using the building as a school much the same as this gentlemen. The soccer association is a big part of the community and the historical society is important to the community. He asked why another party was brought in to negotiate the purchase of something that could be willingly purchased by one of the other occupants. Mr. DeMichael asked if Mr. Borror was suggesting Medina Creative Housing was interested in purchasing the building and Mr. Borror said yes. Mr. Borrer said Ms. DiPasquale Hagerty started negotiating with Mike Todd before he left town and asked why negotiations were stopped. Mr. DeMichael asked Mr. Ostmann to respond to that question

Sale of Remsen Building Con't

Mr. Ostmann said there were complaints about the way Medina Creative Housing was maintaining the property. He said he wasn't Trustee when they went in there. There is only a Memorandum of Understanding not a lease and he thought because of the money Medina Soccer Association has put into that building that we should try to negotiate with them to purchase the property but when we got down to finalizing the sale another offer came in. Trustees have negotiated with Medina Soccer and there were a lot of things to negotiate but I thought we had a deal with them at that point. Mr. Borror said Medina Creative asked to do some roof work to make use of those classrooms and they were turned down. He encourages the Trustees to rethink the process and talk to the occupants that are in there.

Mr. Clardy said they have multiple businesses and they do have a 501C3 called Peace Works, Inc. which will be the corporation that buys the Remsen building. Intervention for Peace will be the largest donor to Peace Works, Inc. He said if Medina Creative Housing wanted to do this they should have stepped up and done it. He said they need the area WPS has and they can provide another space on their dime.

Mr. Clark said Ms. DePasquale-Hagerty wanted to place a bid and was told by Ken DeMichael that she could not put a bid in because they had an agreement with Soccer. Ms. DePasquale-Hagerty is out of town but she will come to the next meeting to discuss this. Mr. DeMichael said he was not the one to shut her out.

Mr. Clardy asked Ray if he said he wanted something in writing. Mr. Jarrett said he would like to see, in writing, from whatever parties are involved, any agreements to come before the Board of Trustees. Mr. DeMichael said the problem with that is it is ultimately this Board's decision and you are suggesting WPS can dictate to what extent they're going to use the building going forward

Mr. Clardy asked who he should meet with from WPS because he hasn't heard back from Tom Barko. Mr. Ostmann asked for Mr. Clardys phone number.

Mark Radice (4036 Stonegate) asked why the Township feels they need to be in that mix and is WPS a public or a private group. He feels the Township is going to open a can of worms and what if Stonegate wanted to start a preservation society are you going to be obligated to protect stuff for them and if this gentleman wants to buy it let him protect the WPS. He said to put it up to auction. Mr. DeMichael asked what happens if another group in the community is looking to be preserved or funded in any way shape or form. Mr. Ostmann said we own this building we don't own anything in Stonegate.

Mike Kaminsky would like the Trustees to meet some of the people that *inaudible* and have helped for twenty years and if we use the building for something like that, that is what the builders have intended. He doesn't like the way the building is used right now and they have to have windows in offices. Mr. Ostmann thanked everyone for their comments and they will be moving forward with this.

OTHER BUSINESS

Amendment of March 23, 2017, Supplemental Appropriations

Mr. Ostmann motioned to amend the March 23, 2017, supplemental appropriation to state we are moving \$10,000.00 from fund number 2111-760-730-0000 to fund number 2111-220-318-0000 for training expenses. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Approval of Accounts Payable

Mr. Ostmann motioned to approve accounts payable checks #28217 through #28248 in the amount of \$50,921.38. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Approval of Payroll

Mr. Ostmann motioned to approve payroll check #23087 through #23141 in the amount of \$54,596.46 with \$7,808.18 withheld for taxes, union dues, etc. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

OTHER BUSINESS CON'T

Approval of Minutes

Mr. Ostmann asked if everyone had reviewed the minutes so they could be approved. Mr. DeMichael said he hadn't reviewed the minutes (April 10, 2017 and April 20, 2017). Mr. Ostmann said okay. Mrs. Goe asked if he had reviewed either one and Mr. DeMichael said no. Mrs. Goe said you have had those for a long time. Mrs. Ventura said are those still the ones because she wasn't at the meeting. Mr. DeMichael asked which ones they were. Mrs. Goe said there is a set for you and Bill to sign and a set for you, Bill and Ray to sign. They weren't approved because Ray was out of town. Mrs. Goe said she had sent them to everyone to review. She told Mrs. Ventura that she had already made her corrections. Mr. DeMichael asked if this is the special meeting and was told yes. Approval of the minutes was tabled.

Jeff Johnson (3920 Huffman Road) complimented Denny Miller on the wonderful job that was done on the roads and he thanked the Police for the good job they do having the landscapers remove their vehicles from blocking the roads. Mr. Johnson said there is a zoning issue with vehicles on Fenn Road and with the house 2 doors down. Mr. Ostmann said the issue with the cars on Fenn Road is in the Prosecutors Office and they have vin numbers, license plate numbers and they are investigating it. Mr. Ostmann said right now it doesn't look like they will be able to do much with it. The Prosecuting Attorney who is handling this will send a letter with his determination when finished. Mr. Johnson disagrees. There is a house on Fenn Road that has a lot of cars and debris in their yard.

Mark Radice (4036 Stonegate) asked what happened to the sale of the property that was on the agenda. John Basilone (4971 Shady Brook Run) asked if there was a sale price for the building and was an appraisal done. Mr. Ostmann said no. Mr. Basilone said you should have the building appraised no matter who is in it to see what it is worth. Mr. Basilone asked if we could get a better sign for the Police Department. He also said we could have a microphone system. Mr. Jarrett said we got the tax value from the Auditor's Office.

Matthew Galla (3503 Hamilton Road) said the building was bought for \$80,000.00 but he doesn't know how much money was put into the building.

Mark Radice (4036 Stonegate) said he agrees on the appraisal but we had an offer of \$290,000.00 so they should forget about the appraisal.

Sally Gardner (3333 Foskett Road) said Western Reserve Land Conservancy is having a celebrate Mom's at Medina Marsh on Saturday, May 1, from 10am to 1pm. Also, she wants to know who is getting the money for buying RING that is on the website and she doesn't feel we should be advertising for a company.

Mr. Ostmann motioned to close the floor for public comment. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Mr. Ostmann motioned to adjourn. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael. There being no further business to come before the Board the meeting was adjourned at 8:56 pm

The Medina County Historical Society board of Trustees opposes the sale of the Weymouth School building, 3334 Remsen Road, Medina, OH, erected in 1925 as part of the surrounding property unless specific deed restrictions preserve and protect this important structure. This building is significant and has served a very important role in Medina County history.

Our county has lost many of the original school houses due to neglect or demolition. This particular building has been carefully restored by volunteers with the majority by private funds and the museum holds many archives pertaining to Medina Township. The school was significant in our county history. Children and adults of all ages benefit from seeing the buildings used as intended and gain a unique perspective on history when they visit. The historic marker information at the site confirms the school was the first of its kind to educate handicapped and special needs children. This was a significant milestone in our county's history and is worthy of preserving for future generations. The Weymouth Village and surrounding areas of Medina Township was a vital economic and social hub as our county was born 200 years ago.

Please give serious consideration to the negative impact of selling this building without proper protection of the school. The Medina County Historical Society respectfully requests the building be permanently preserved and owned by all the people of Medina Township. WPS, whose mission statement insures that it will protect the building in its original condition, is the best guardian for it.
