## RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING JUNE 29<sup>th</sup>, 2017 7:00 PM

The Medina Township Board of Trustees met in regular session at the Service Department on June 29<sup>th</sup>, 2017, to conduct the business of the Township. Chairman Ostmann called the meeting to order at 7:01 pm with the following Trustees in attendance: Bill Ostmann, Ray Jarrett and Ken DeMichael. Also in attendance were the Fiscal Officer, Fire Chief, Road Superintendent, Zoning Inspector, Law Director, Mayor Hanwell, Chief Painter and the general public.

#### Roll Call

Mr. Ostmann asked for a roll call of all members present. Trustees present were Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

## **Pledge**

Mr. Ostmann led the Pledge of Allegiance.

#### **Moment of Silence**

Mr. Ostmann asked for a moment of silence for our service members both here and abroad and for our first responders who are risking their lives every day to keep us safe.

## Fresenius Kidney Care - 3995 Medina Road - Sign

Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve the sign on the portico for Fresenius Kidney Care not to exceed 12.66 square feet as presented. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

#### Medina Glass - 3643 Pearl Road - Addition

Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve a 4,800 square foot addition to Medina Glass located at 3643 Pearl Road as presented. Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve a tenant panel to be placed on the existing identification sign for All State located at 3812 Pearl Road not to exceed 8.625 square feet as presented. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

#### Presentation by Mayor Hanwell

Mayor Hanwell, who has been with Medina City for over three (3) decades, gave his presentation regarding combined fire services for Medina City and Medina Township and read the Medina Township Fire Services Timeline and Media Talking Points for the Fire Contract (see attached documents). He explained the history with Mayor Roberts, Mayor Leaver and the Township for an attempted collaboration with the City and Township Fire Departments that was obstructed by Township fire staff. Mayor Hanwell said there have been allegations that the Trustees have been meeting with him illegally and he stated that at no time was there more than one Trustee during his meetings with the Trustees. Mayor Hanwell said before the City makes a commitment his staff analyzed the calls and manpower of the township (see attached).

The following people commented on the Fire Department issue:

Mark Radice said Mayor Hanwell does not have all the knowledge needed to form a fire district. He asked for documentation that the Township walked away from a fire district. He feels the contract isn't worded properly. John Basilone said he feels this is more of a financial decision and he asked what happens to the levy money. Mr. Ostmann said if and when a contract would be voted on the city would do an assessment of our fire equipment. Mr. Ostmann said we will maintain ownership of all equipment the city is just using it.

Fire Chief Crumley gave his presentation.

## **Executive Session to Discuss Employee Discipline**

Mr. Jarrett motioned to enter into Executive Session with the Full Board, Chief Painter and Chief Crumley to discuss employee discipline. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. Jarrett, Mr. Ostmann and Mr. DeMichael. The Board entered into Executive Session at 9:32 pm. The Board reconvened at 10:22 pm. No decisions were made during that meeting.

## **Medina Township Fire Services- Timeline**

- 1) History- Mayor Leaver and Mayor Roberts both attempted collaborations with city and township Fire Departments- obstructed by Twp. Fire staff
- 2) Nov. 4, 2016- Bill Ostmann approached me at event to advise of interest in near future of discussing fire district or combined operations.
- 3) Jan. 6, 2017- Met with Ray Jarrett and chair of citizen group in Township to answer questions ref. our fire operations vs theirs; costs of services; etc
- 4) Contacted by Bill Ostmann to check with interest in township contracting with Medina City for Fire Services like we have for Montville for 50 years
- 5) Jan. 19, 2017- I met with Chief Grice, Jeff Brandon and Bill Ostmann and city Connections.
- 6) 1/30/17- Lunch with Jeff Brandon and Ken DeMichael to discuss contract for fire services in hopes of working toward a fire district.
- 7) March 2- Met with Greg Huber, Bill Thorne and Bill Ostmann to discuss parameters of contract which was drafted by Bill Thorne then minor wording modifications through meetings and discussions with the four of us.
- 8) May 17, 2017- Bill Ostmann and I met with Chief Painter in my office to discuss future fire operations as proposed by contract.
- **9)** June 8, 2017- Ray Jarrett and I met with Chief Painter in my office to discuss future fire operations as proposed by contract and current staffing concerns.

## **Media Talking Points for Fire Contract**

- 1) City will provide equal or better fire services for less cost (\$230k year)- 36%
- 2) City will take over all fire operations- hydrant flushing, plan review, call stat review, inspections, vehicle maintenance, etc.
- 3) Improved ISO rating for township by contracting with city helps with residential and business insurance rates
- 4) City will permit Medina Township firefighters to apply for positions with city fire department; must live within radius of station and pass requirements of city. Those that meet requirements and pass tests are paid a higher rate at city and have civil service protection.
- 5) Staffing levels- City will increase from 3 to 4 staff members from 8a to 4p Monday through Friday (supplemented by full time members Chief, Fire Marshall, and Captain. Second shift will increase from 4 to 6 staff members from 4p to midnight, with 3 at Nettleton Station and 3 at the Fire Station One at East Reagan and North Huntington Streets.
- 6) Analysis of calls by day of week and time of day was plotted for Montville Twp., Medina Twp., and the city, and the aforementioned stations selected to maintain positive response times to all three jurisdictions.
- 7) Contractual arrangement with Montville and Medina Twp.s is first step toward future fire district for at least the three jurisdictions, as well as opportunity to consider additional jurisdictions.
- 8) More effective and efficient use of staffing, stations, and equipment to provide fire services to region.
- 9) Improved grant opportunities due to collaborations.

Rebuttal to Capt. Roberts comments to media:

- 10) Claimed MTFD had 600 runs when in fact over past 3 years (2014, 2015, 2016) they have handled 392, 454, and 407 in those years respectively. That is an average of 418 annually or 1.15 calls per day which includes EMS calls as well as fire calls.
- 11) If we look at just fire and rescue related calls they have had in same years 232, 291, and 231 in those years respectively. That is an average of 251 annually or .68 calls per day.
- 12) EMS Director/Doctor for Medina Hospital establishes guidelines for when fire medics should respond to calls for EMS as they are acting under the hospital's licensing. MTFD has ignored such guidelines to run on all LST runs with emergency equipment when the PROQA program as well as EMS Director guidelines both suggest against such on a number of non-emergency calls. To operate without regard to the guidelines established exposes the Township, the Trustees, and the Township residents to additional liability and risk of lawsuit.
- 13) Staffing numbers- those who meet minimum standards and requirements will be considered for entry into Medina Fire Dept. We will have room to add more firemen to help all three jurisdictions with calls. Medina has provided fire services to Montville Twp. for at least 55 years effectively and efficiently and will do same for Medina Township.
- 14) We will not close the stations, but reassign our staffing members to them.
- 15) After Council passed Ord. Monday, no Township Firefighters showed up for duty Tuesday, 6/13- risk to residents- hypocritical.

16) This decision was not done in a rush. Mayor Roberts and Mayor Leaver prior to me both attempted to collaborate with Medina Twp. fire. I have worked for past 7.5 years as Mayor/Safety Director to have Medina Twp. Fire Chief and our Fire Chief work to train together, get policies and procedures in line with each other, work toward shared staffing at my and Trustees request. Each attempt was obstructed and failed due to actions of Medina Twp. Fire Chief even though Trustees directed him to do so. So when I was approached by Trustee to review and analyze possibility of contracting for fire services, it was done without input of fire staff to avoid the past obstructions and lack of cooperation.
