RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING AUGUST 10TH, 2017 7:00 PM

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on August 10th, 2017, to conduct the business of the Township. Chairman Ostmann called the meeting to order at 7:01 pm with the following Trustees in attendance: Bill Ostmann, Ken DeMichael and Ray Jarrett. Also in attendance were the Fiscal Officer, Police Chief, Fire Chief, Road Superintendent, Zoning Inspector, Law Director and the general public.

Roll Call

Mr. Ostmann asked for a roll call of all members present. Trustees present were Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Pledge

Mr. Ostmann led the Pledge of Allegiance.

Moment of Silence

Mr. Ostmann asked for a moment of silence for our service members both here and abroad and for our first responders who are risking their lives every day to keep us safe.

Supplemental Appropriations

Mr. Ostmann motioned to transfer \$1,500.00 from account #1000-110-319-000 other professional/technical to account #1000-760-730-0001 improvement of sites — Remsen Building. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Approval of Accounts Payable

Mr. Ostmann motioned to approve accounts payable checks #28479 through #28516, total amount of \$39,715.06. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Approval of Payroll

Mr. Ostmann motioned to approve payroll checks #23453 through #23475 total amount \$39,220.77 with \$7,204.03 deducted for taxes, OPERS, union dues, etc. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Approval of July Department Reports

Mr. Jarrett motioned to approve the July department reports for zoning, police, fire and roads. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Jarrett, Mr. DeMichael and Mr. Ostmann.

Work Zone Traffic Control and Safety

Mr. DeMichael motioned to approve a training request for Denny Miller, Jeff Kessler, Craig Plute, Martin Mohler and Keith Kessler to attend a workshop, Traffic Control & Safety Workshop at Brunswick Hills Township August 30, 2017. There is no cost to this. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett.

DEPARTMENT HEAD COMMENTS

Police Department

Chief Arbogast thanked everyone who participated in the First Annual National Night Out – Cooking with Cops, Yours Truly Restaurant, WalMart, Quaker Steak & Lube and Santosuossos. It was a great success and a great community event. We were selected for a Change Starts Now through the Ohio collaborative, videos are on website.

DEPARTMENT HEAD COMMENTS CON'T

Fire Department

Chief Painter said for our first month of service we had thirteen (13) calls. Seven (7) were EMS, we had three (3) difficulty breathing, one (1) diabetic, two (2) altered mental state and an unresponsive person. We had two (2) fire alarms one (1) residential and one (1) commercial, two (2) motor vehicle accidents and four (4) fire service calls. One (1) was a lightning strike that hit a gas meter line which turned into a fire, one (1) carbon monoxide and odor investigation, a mulch fire at Smith Brothers and we also did three (3) inspections. I found the report format in the computer so we will be including the percentages. On the inspections, we pulled out the records and from January to March they had eighteen (18) inspections done and from April until July there were zero (0) done in the Township. We are still sorting through documents to see if something could have been missed or not entered. Your IT people and our IT people are working to get the Fire House Inspections folder moved over to our system. Currently, for whatever reason, your system is three (3) updates behind and it is all on the web. The IT people are working to get those updates in so we can transfer it. Once it is transferred we will be able to pull reports and see who is overdue for inspections and work the high hazard areas first and get through that. Chief Painter said they are also scheduled with ISO, the Insurance Services Organization to start the re-evaluation process in mid-September for all residents. ISO evaluates Fire Departments for the insurance industry and ranks us and that's what your rates are. Currently the City and Montville Township is at a three (3) and 8B in the non-hydranted areas and right now Medina Township is at a five (5). The lower the number the better discount you get. After speaking with the rep today with our station #1 being involved there should be no issue with getting the three (3) for the Township also. We have been rotating apparatus to insure proper use and training for our guys so don't be surprised if you see one of our City trucks parked for a few days a week and your truck is gone. Chief Painter said he has been quiet through this whole contract process but there continues to be misinformation and half-truths and some are complete fabrications that are being spread on social media by some of the past Township firefighters. In my mind the only purpose is to install fear and panic in the minds of residents. He addressed a few of these issues. First, Medina City Fire Department has enough staff and equipment to protect all the residents within our district. Last Friday was a prime example: we handled two (2) fires, an extrication, two (2) motor vehicle accidents in a four (4) hour window. During the fires we had an extrication and an accident during the second fire, they all happened simultaneously. It happened in all three (3) communities and we had over twenty (20) firefighter's midday on a Friday and that is pretty good. There have also been some postings saying no one lives in the Township. From June 2017, you had a roster and of the forty (40) firefighters listed, thirteen (13) were Township residents, fifteen (15) lived in the City or Montville and the other ten (10) lived out of the area and there were two (2) with no address listed. There has also been criticism of our hiring process. Of the forty (40) firefighters only twelve (12) have taken out applications so far. Seven (7) have been returned and we have interviewed three (3) of those with four (4) being scheduled for interviews. We cannot hire or process anyone who has not applied so we're not sure where all these concerned firefighters are right now. Chief Painter said he is a Medina Township resident and he wants to assure his neighbors, friends and fellow residents that the Medina City Fire Department will provide the best possible fire protection for the Township residents. We serve the Township with pride and professionalism as we have the City for one hundred forty-three (143) years and over fifty (50) years for Montville Township. If any of the residents have questions, concerns or need clarification on these rumors that they have been hearing please call him at 330-725-1772.

OLD BUSINESS

Amendment to Employee Handbook Regarding Sick Hours

Mr. Jarrett said he is fine with the language that was presented to them as it stands. Mr. DeMichael asked what was presented, do you mean to me or the Police Department. Mr. Ostmann said the one they received. Mr. DeMichael said that does not mirror the Police Department and why should they be different. Mr. Jarrett said we do not have an estimate of our unfunded liabilities, which this is, and until I see what the projected cost would be to the Township I don't want to see an increase in our funding if we have not projected what it is going to cost us. Mr. DeMichael said you didn't take the time to do those calculations and Mr. Jarrett said we asked the Fiscal Officer if she could project that out for us. Mr. Jarrett said if we could have something that shows us what our payout is going to be that would be sufficient to show our unfunded liabilities. Mr. Ostmann said to table it for now and Mr. DeMichael agreed.

Contract for Use of Blakslee Concession Stand

Mr. Ostmann said the contract will need to be modified by our Law Director. Mr. Miller said we just have to come up with a cost. Mr. Jarrett asked Mr. DeMichael if he had any suggestions and Mr. DeMichael said no. Mr. DeMichael said he received and e-mail regarding the handicap spots that were taken down because of the restrooms. Mr. Miller said there are handicap restrooms and we can put handicap signs up. Mr. Ostmann said technically they should have them and there is a formula on how many regular spots and how many handicap spots you have to have. Mr. Ostmann said they will table this until the contract is modified.

Use of One Trash Hauler in Township

Mr. Ostmann said Mrs. Goe has been working on this and found it is a lengthy process. It is not something that can be done in a few months. Mrs. Goe said it took them almost a year and they had to apply for a grant for the cans and you can't apply for the grant until the spring. Montville will send their information as soon as they get it together. Mr. DeMichael asked if we had to wait until spring to apply for the grant and Mrs. Goe said yes. Mr. DeMichael asked if we could stay on top of it. Mr. Ostmann said they had to have a citizens committee. Mrs. Goe said the committee consists of eight (8) people and they meet five to six times during the year and it does not have to be advertised but one of the Trustees has to attend the committee meetings. Mr. Ostmann asked if they also do the recycling and Mrs. Goe said yes they still do the recycling bins and residents have the option to opt-out of the program but the one trash hauler wants to do the whole Township, they do not want residents opting out. The committee also decides on the color of cans, how many is needed, etc. Mrs. Goe asked Mr. DeMichael if he wanted her to give him all of the information and he said sure. Mr. Jarrett said it makes sense to just have one trash hauler once a week and it might help with the roads. Mr. Ostmann said he read the quotes and it would definitely save the residents money. Mrs. Goe said Montville received a \$180,000.00 grant and after purchasing the cans they had about \$60,000.00 left to use to pay the trash hauler.

Fire District Committee

Mr. Jarrett met with Montville Township and they have selected their committee members and they will be giving their selections to the City of Medina tomorrow. Mr. Jarrett said his selection for the committee is William West. Mr. Ostmann selected Gary Vene. Mr. DeMichael selected Mark Radice. This information will be forwarded to Mayor Hanwell.

NEW BUSINESS

Resolution to Cease Collection of the 2003 Continuing Fire Levy

Mr. Ostmann offered the following resolution and moved for the adoption of the same:

RESOLUTION NO. 08102017-018

A RESOLUTION TO CEASE COLLECTION ON THE 2003 CONTINUING FIRE LEVY, FOR THE LIFE OF THE PROPOSED JOINT EMERGENCY SERVICES LEVY, IF PASSED, AT THE NOVEMBER 7TH, 2017, GENERAL ELECTION.

Whereas, The Board of Trustees is proposing for the consideration by the Township electorate a five year joint emergency services levy for all uses allowed by law for fire, police and emergency rescue services; and

Whereas, if the voters approve said levy, collection on the existing fire levy for said period will be unnecessary to finance fire operations under the contract with Medina City.

Now Therefore, be it resolved, that if the proposed five (5) year joint emergency services levy is passed by the voters of Medina Township at the election on November 7th, 2017, that the Board direct the County Auditor and Treasurer to cease collection on the 2003 fire levy for the life of the joint levy.

Mr. Jarrett seconded the motion. Mr. DeMichael said he had a better idea. Why don't we just roll back the levy now and then if the levy doesn't pass we can just reinstate it because we have that authority. Mrs. Ventura said we have to keep collecting; we can't roll it back now. Mr. Ostmann said we would have to wait until the end of the year to do that. Mrs. Ventura said she would assume but, even if we don't, because we ended up owing them some back for the first half we would want to collect everything for the rest of 2017 so we break even with the County. Mr. DeMichael said he wasn't following what she said. Mrs. Ventura said because of the Homestead and H.B.58 rollbacks we didn't get as much money in as they had anticipated so we took an advance from the County, Instead of a lump sum we get payments twice a year. We were paid more for our first half tax advances then we brought in so each department ended up owing some back. It is going to be rectified in the second half. Mr. DeMichael said isn't there enough money in the fire fund to be able to pay that. Mrs. Ventura said yes there is enough money but we don't have an idea of exactly what we are going to be spending because of utilities and cost of maintenance to the buildings and things like that. She doesn't want to put us in a position down the road that we may have to go back and ask for more money but that is up to you guys. Mr. Jarrett asked if this will take us to the end of the year, Mr. DeMichael said is there \$900,000.00 in there. Mrs. Ventura said there is \$866,710.32. Mr. DeMichael said we shouldn't have that issue and Mrs. Ventura said we won't have that issue right away but she wants to be on the safe side. Mrs. Ventura said she wasn't sure what Mr. DeMichael's reason was. Mr. DeMichael said we were just adding a step and if we put this in place does it eliminate the possibility of reinstating that 2mil levy. Mrs. Ventura said yes. Ms. Graffein of the Auditor's Office said they need to speak to Mrs. Guenther about this and that the tax advances are done for the year but you may not have gotten them yet.

Mr. Ostmann rescinded his motion and Mr. Jarrett rescinded his second.

Amendment to the Fire Contract

Mr. Ostmann said amendments to the fire contract were put in everyone's box and they have not been reviewed so they will look at it at the next meeting. Mr. DeMichael asked where the amendments came from and what the purpose of them was. Mr. Jarrett said they came from him because we all discussed about the generalities of the contract and I wanted more specifics. Mr. DeMichael said the one he had a question on specifically was to get out of the contract, it went from six (6) months to a year, what was the purpose of that? Mr. Jarrett said the purpose was that if there was a reason to get back in, it gives enough time to get the function in its organizational state; six (6) months will be a little too short. Mr. DeMichael asked if he spoke to the City about the changes and Mr. Jarrett said yes, he did.

Food Drive

Mr. Jarrett said this is the 6th annual food drive that the Township has had. Mr. Jarrett said last year they collected \$139.00 and 2,880 pounds of food. Hopefully we can either match or exceed that number. Mr. Jarrett passed out flyers listing the foods needed. The food drive starts today and will end on November 4, 2017. Food can be dropped off at the Townhall between the hours of 9am to 4pm Monday through Friday.

PUBLIC COMMENT

Mr. Ostmann motioned to open the floor for public comment. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Carol Feron (3335 Myers Road) said the Weymouth Preservation Society had their potluck that was very nice and well attended. They will be hosting Leadership Medina again and we are having a cemetery tour. The restrooms will be open on Weymouth Day and we plan on selling root beer floats and the scouts will be selling food. Mr. Jarrett asked what troop would be there and she said she thinks it is 506.

Ian Jones, MSA (328 E. Liberty Street) asked what the status of the selling of the Remsen Building was and also the drain in the middle of the parking lot is getting worse and floods whenever it rains. He is concerned someone is going to drive through there and the grate won't be there anymore. Mr. Ostmann said there is a lawsuit by one of the people that wants to purchase it so until that is resolved it is in limbo. Mr. Ostmann said the only way to fix the drainage issue is to tear up the whole parking lot up. Mr. Miller has jetted it and tried camering it. Mr. Jones said don't you consider it a safety issue. Mr. Jarrett asked Mr. Miller where the problem is at, is it a collapsed line. Mr. Miller said it is a collapsed line between two (2) catch basins and it is only a six (6) inch pipe. Mr. Jarrett asked what the distance was between the two (2) driveway pipes. Mr. Miller said about 100 feet. You would have to put in a new line. Mr. Jarrett asked Mr. Miller to get cost estimates.

John Basilone (4971 Shadybrook Run) said we should sell the building as soon as the injunction is done and sell it as it is. He also said he asked about the Workers Compensation Rebates. Mrs. Ventura said she has a call in to our rep. Mr. Basilone said it is \$26,750.00 refund to Medina Township. Mr. Basilone asked why the Law Director wasn't at the meeting.

Charles Macuga (3146 Champions Way) asked what the plan was for the \$866,000.00 that is left in the fire fund. Mr. Ostmann said it will be used to pay for the fire contract or equipment but if the safety services levy passes then the 2mil fire levy will be rescinded and the money that is in there will be gradually spent down to be used for fire protection.

James Apana (3993 Dogleg Trail) welcomed Chief Painter to the Township and said there is some confusion in his community as to what the hours are that the stations are open and what equipment is there. Chief Painter said they are staffing station#1 on Reagan Parkway Monday through Friday 8am to 4pm with three (3) firefighters and the three (3) full-time firemen which is a total of six (6) people. After 4pm, based on the call volume and location, the Nettleton Road station has three (3) firefighters and Reagan Pkwy Station has (3 firefighters on duty from 4pm until midnight. Weekends and night shift has the slowest call volume we are on call at that point. Mr. Apana asked about the fire station here. Chief Painter said this station is an on call station. After midnight all stations are on call and dispatch has it broken out by the zones. Chief Painter said they found that these were the two (2) busiest areas for the City and the Townships. Chief Painter said they are staffing more hours and both stations are closer to the Township than what they had in the past.

Matthew Galla (3503 Hamilton Road) heard on the radio that a person has a gym in Atlanta, Georgia that has a sign that says no police or military personnel are allowed. He feels all the trouble is with the police and the military and feels if people don't like it here they should leave the country.

Mr. Ostmann motioned to close the floor for public comment. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Mr. Ostmann motioned to adjourn. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael. There being no further business to come before the Board the meeting was adjourned at 7:47pm.
