RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING OCTOBER 5TH, 2017 7:00 PM

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on October 5th, 2017, to conduct the business of the Township. Chairman Ostmann called the meeting to order at 7:00 pm with the following Trustees in attendance: Bill Ostmann, Ken DeMichael and Ray Jarrett. Also in attendance were Fiscal Officer Ventura, Fire Chief Painter, Police Chief Arbogast, Road Superintendent Miller, Zoning Inspector Ridgley, Law Director Thorne and the general public.

Roll Call

Mr. Ostmann asked for a roll call of all members present. Trustees present were Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Pledge

Mr. Ostmann led the Pledge of Allegiance.

Moment of Silence

Mr. Ostmann asked for a moment of silence for our service members both here and abroad and for our first responders who risk their lives every day to keep us safe.

SITE PLANS

Multi-Tenant Building - Ground Sign - 4184 Pearl Road

Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve a 30 square foot ground sign for the Multi-Tenant Building located at 4184 Pearl Road as presented. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Panera Bread - Drive-thru - 4065 Pearl Road

Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve a drive-thru for Panera Bread located at 4065 Pearl Road as presented. It was so noted that the pedestrian crossing in front of the drive-thru be clearly marked for safety purposes. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Crystal Asia Spa - Site - 2747 Medina Road

Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve the change of use for Crystal Asia Spa to be located at 2747 Medina Road Unit #191 as presented. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Take 5 Oil Change - Wall Sign - 4215 Pearl Road

Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve a wall sign (facing Pearl Road) for Take 5 Oil Change located at 4215 Pearl Road not to exceed 47.25 square feet as presented. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Take 5 Oil Change - Second Wall Sign - 4215 Pearl Road

Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve a second wall sign (on Ledgewood Drive) for Take 5 Oil Change located at 4215 Pearl Road not to exceed 29.82 square feet as presented. It was so noted that a second wall sign is permitted as this business is located on a corner lot. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

SITE PLANS CON'T

Take 5 Oil Change - Ground Sign Face Change - 4215 Pearl Road

Mr. Ostmann motioned to accept the recommendation of the Zoning Commission and approve a face change of the existing ground sign for Take 5 Oil Change located at 4215 Pearl Road not to exceed 32 square feet as presented. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

OTHER BUSINESS

Mark Herwick - Homestead Insurance

Mark Herwick of Homestead Insurance asked Trustees if they received the Medical Mutual renewal documents that he dropped off previously and was told yes. He then presented the Trustees with some documents regarding changes they may wish to consider. He said it was nothing they had to vote on. The confidential outline is just the 2018 projected plan costs. There may be changes to the numbers after the election. The medical renewal was 2%, dental was 3.11% and vision was 0%. He said the costs have stayed pretty level and the renewal date for all contracts will be January 1. Mr. Herwick checked the IRS website and the HSA can be paid annually, semi-annually, quarterly, monthly, any way you choose but it has to be the same for everyone. Also, because you fund the HSA accounts based upon enrollment, if there are spouses or adult children that can get insurance through their employer then you may want to set some parameters to your plan and then we would put them in your plan documents so that it prevents abuse of the system because the plan is very generous and the donations are very generous. Mr. Jarrett commented on the decrease in the cost for the plan since 2015.

Erica Graffein - Medina County Auditor's Office

Erica Graffein, Medina County Auditor's Office said we have contracted with a company for the 2019 reappraisals. They will have an Auditor's Office ID. They will not come into your home. They will leave a door hanger to identify that they were on your property. There will be no need to call unless they leave a door hanger asking you to call.

Supplemental Appropriations

Mr. Ostmann motioned to move \$200.00 from account number 2031-330-230-0000 to account number 2031-330-229-0000 and to move \$17,000.00 from account number 2031-760-720-0582 to account number 2031-330-740-0000 and to move \$99,251.17 from account number 2111-220-190-0000 to account number 2111-220-360-0000 and I attach 1 page document dated 10/5/17 by reference. Mr. DeMichael seconded the motion. Mr. DeMichael asked what the \$99,000.00 and the \$17,000.00 that we are moving was for. Mrs. Ventura said the \$99,000.00 is the proration amount for the fire contract from July 13, 2017 until December 31, 2017 and the \$17,000.00 was for a purchase order for a chipper and the \$200.00 was for other insurance. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Approval of Accounts Payable

Mr. Ostmann motioned to approve accounts payable checks #28584 through #28616, total amount is \$61,459.26. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Mr. Ostmann motioned to approve accounts payable checks #28617 through #28662 total amount \$123,358.70. Mr. DeMichael seconded the motion. Roll call vote: Mr. Ostmann aye, Mr. DeMichael no, Mr. Jarrett aye.

Approval of Payroll

Mr. Ostmann motioned to approve payroll checks #23550 through #23569 total amount \$32,816.60 with \$5,945.06 deducted for taxes, OPERS, union dues, etc. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Mr. Ostmann motioned to approve payroll checks #23572 through #23594 total amount \$36,323.87 with \$7,041.71 deducted for health care, union dues, etc. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

OTHER BUSINESS CON'T

Approval of July Bank Reconciliation

Mr. Ostmann motioned to approve the bank reconciliation for August. This is a three (3) page document and I will incorporate the document by reference. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Approval of Minutes

Mr. Ostmann motioned to approve the following minutes as written: the July 27, 2017, regular meeting, the August 10, 2017, regular meeting, the August 24, 2017, regular meeting, September 7, 2017, regular meeting, September 11, 2017, public hearing and the September 11, 2017, emergency meeting. Mr. Ostmann amended his motion and withdrew both the September 11, 2017, public hearing and emergency meeting. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Mr. Ostmann motioned to approve the minutes for the September 11, 2017, public hearing and the September 11, 2017, emergency meeting. Mr. Jarrett seconded the motion. Roll call vote: Mr. Ostmann aye, Mr. Jarrett aye and Mr. DeMichael abstain. Mr. DeMichael was not in attendance at those two (2) meetings.

PURCHASE ORDERS AND TRAINING REQUESTS

Treemasters Tree Service - Open Space on Sassafras

Mr. DeMichael motioned to approve a purchase order requisition for our admin department. Vendor is Treemasters Tree Service. This is to put nine (9) trees on the ground at 5204 Sassafras in the rear open space, They called in and there is a hazard of dead trees, \$850.00 is the total. Mr. Ostmann seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Ostmann and Mr. Jarrett.

Treemasters Tree Service - Chipper - Service Department

Mr. DeMichael motioned to approve a purchase order requisition for our Service Department. The vendor is Treemasters Tree Service. This is to purchase a used 2012 Vermeer wood chipper. The total amount is \$16,500.00. Mr. Jarrett seconded the motion. Mr. Jarrett asked how many hours are on the chipper. Mr. Miller said there are 560 hours. Mr. Jarrett asked who we are getting it from and what size logs will it take. Mr. Miller said from Treemasters and it will take logs up to 12 inches. Mr. Miller said they have been borrowing Hinckley's quite a bit but when there is a storm they both would need to use the chipper. Voting aye thereon: Mr. DeMichael, Mr. Jarrett and Mr. Ostmann.

City of Medina Fire Contract Fee

Mr. Ostmann motioned to approve a purchase order and the vendor is the City of Medina. The total amount is \$99,251.17 and this is the fire contract fee from 7/13/2017 through 12/31/2017. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

RING - Video Doorbells - Police Department

Mr. Ostmann motioned to approve a purchase order requisition. The vendor information is RING and this is grant funded and there is a blanket purchase order on file. It is for twenty (20) video doorbells for \$2,980.00 and five (5) video doorbells for \$745.00 and the total on that is \$3,725.00. Mr. Jarrett seconded the motion. Chief Arbogast said it is a program for seniors or people on a fixed income and the only criteria is that they have to have a smart phone. This is where someone rings your doorbell and a camera comes on. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Montville Township Shared Detective - Police Department

Mr. Ostmann motioned to approve a purchase order requisition. The vendor is Montville Township. The department is Police and it is for one twelfth (1/12) the cost of the shared detective for 2017 and the total amount is \$6,433.11. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett. Mr. Jarrett asked if that was working out and Chief Arbogast said yes the detective spent a lot of time on the arrest of the Lacrosse person.

Department Reports

Mr. Jarrett motioned to approve all department reports regarding zoning, police, fire and roads. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Jarrett, Mr. DeMichael and Mr. Ostmann.

DEPARTMENT HEAD COMMENTS

Police Department

Chief Arbogast said that as part of the grant they were able to obtain a number of lock boxes. The criteria is that you over 65 years of age and on a fixed income, a disabled veteran or disabled at any age or you have a specific medical condition that warrants response entrance to your home. They must also be a Township resident. A form can be filled out online or you can go to the Police Station and the Police will come out and bring the lock box. The person would set the code and give it to us on a secured area of our call record and your address would come up when dispatch is called. The Police Department will host a Halloween party for children up to 12 years of age October 31 from 4 to 6pm. There will be hot dogs, games and give-a-ways. Wear your costumes. Chief Arbogast said 600 Police Departments nationwide hosted a Coffee with a Cop event. Medina Township Police hosted their event at Yours Truly and the Chief bought coffee for whoever came in that purchased a breakfast.

Fire Department

Chief Painter said they had twenty-seven (27) calls for the month and a total of 127 calls for the three (3) communities. They had a structure fire and it was taken care of. He said they are still fielding calls regarding the misinformation about the fire contract. People still think all of the Medina Township stations are closed and all the equipment was liquidated. When we go on calls we try to clarify to the residents that that is not true. Chief Painter invited the public to attend the Fire Departments annual open house at Station One (1) on Reagan Parkway. They will display apparatus, a helicopter is coming in and Corkscrew cooks for us. It will be from 11:00 am to 3 pm on Saturday October 14.

Service Department

Superintendent Miller got a price for repairing the drainage issue in the parking lot at the Remsen building. The cost would be \$38,290.00. He said Mr. Jarrett asked him to get two (2) more quotes and he asked if the Trustees could recommend someone. Mr. Jarrett said he would reach out to a few contractors to see if they would be willing to give us a quote. Mr. Miller received a check for the use of the concession stand from Triple Crown Vending. Mr. DeMichael read the letter (see attached) and turned over the \$500.00 donation. Mrs. Ventura said it will be deposited in the Blakslee Park fund.

Weymouth Preservation Society

Brian Feron reported that the WPS hosted Leadership Medina for a presentation about Weymouth Preservation Society, the history of the Township, a cemetery tour and a talk at the Weymouth Church about abolitionists in the Township and a history of the Church. He stated that as part of the bicentennial celebration they will be hosting a cemetery tour Sunday October 8 from 2 to 6 pm. They are looking for different ideas on how they can clean the cemetery fence because they don't want to run a hose across the road.

OLD BUSINESS

Food Drive

Mr. Jarrett said the food drive will continue through November 4. October 7 from 9 am to 1 pm we will have our big food drive push at Wal-Mart. Our Fire, Police and Service Department will be out there accepting the food or cash donations. Mr. Jarrett asked the Board if they had any issues with employees working those hours and getting paid for them as they have done in the past. Mr. Ostmann and Mr. DeMichael said they have no issue with the employees getting paid as they have in the past. We hope for good weather and a good turnout.

JED Information

Mr. Thorne gave Trustees information regarding the formation of a JED. He has called Bethany Dentler, Director of the Economic Development Corporation three (3) times and stopped in to her office once but she wasn't in. He has not received any return phone calls so he doesn't know if anything is being worked on at this time.

NEW BUSINESS

Resolution Accepting the Amounts and Rates as Determined by the Budget Commission

Mr. Ostmann said there is a resolution accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor that needs to be voted on.

Resolution Number 10052017-020.

Mr. Ostmann motioned that we approve this and I will incorporate this document by reference. It is four (4) pages. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Trick or Treat Date and Time

Mr. Ostmann motioned that we set Trick or Treat date and time to be October 31 from 6 to 8 pm as this is what the City does and everybody else does around here. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Barricades for Party at 5241 Silver Maple Cul-de-Sac

Mr. Ostmann motioned to approve the request by Francis Baffoe for barricades for a party in the cul-de-sac at 5241 Silver Maple Lane from 2 to 6 pm Saturday, October 7. Mr. Baffoe was told that no tents, tables, chairs, etc. are allowed in the road even though it is a cul-de-sac. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Resolution to Cease Collection on the 2003 Continuing Fire Levy

Mr. Ostmann said on reviewing the 2 mil Fire Levy that is on now we did pass a resolution that it would be repealed if the 1.4 mil levy passed. Our reviewing this and knowing now that we don't have to replace equipment for fifteen (15) years and we don't need to build new buildings or anything now would be a good time to repeal it immediately and save the taxpayers some money.

Mr. Ostmann read the following resolution: The Medina Township Board of Trustees, Medina County, Ohio, met in regular session on this 5TH, day of October, 2017, with the following members present: William Ostmann, Chairman, Ken DeMichael, Vice-Chairman and Ray Jarrett, Trustee.

Mr. Ostmann offered the following resolution and moved for the adoption of the same, which will be seconded.

Resolution No. 10052017-021

A Resolution to Cease Collection on the 2003 Continuing Fire Levy, Effective Immediately

Whereas, The Board of Trustees has entered into a Fire Service Contract with the City of Medina, and;

Whereas, on August 24th, 2017, the Board passed Resolution Number 08242017-018 to cease collection on the 2003 continuing fire levy if the joint Emergency Service Levy was passed by the voters at the November 7, 2017, election, and

Whereas, upon further review it has been determined that the existing continuing levy is unnecessary to meet the needs of the contract for the next three years;

Now Therefore, be it resolved, that the Board direct the County Auditor to terminate and cease collection on the 2003 fire levy, effective immediately, with no collection for 2017 due in 2018, or thereafter. Mr. Jarrett seconded the motion. Mr. DeMichael said this is what he suggested doing a few weeks back and he doesn't know what's changed. Mr. Ostmann said now he knows we won't need to buy anymore fire equipment or apparatus for fifteen (15) years which is a huge difference in what he knew last time. Mr. DeMichael said can you say without question we're not going to need aChief Painter said they have a new truck coming in at the end of November and the mechanic has gone through all the trucks and there is no need to replace them.

Resolution to Cease Collection on the 2003 Continuing Fire Levy Con't

Mrs. Ventura asked if upgrades to the fire buildings are needed. Chief Painter said they have gone through the buildings and they don't see anything major that needs to be done just general maintenance. Mr. DeMichael said he feels it's politically motivated and he doesn't see a need to do it before we see if the other levy is passed in four (4) weeks. Mr. Ostmann said okay. Roll call vote: Mr. Ostmann aye, Mr. Jarrett aye and Mr. DeMichael no.

PUBLIC COMMENT

Mr. Ostmann motioned to open the floor for public comment. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael.

Gary Vene (3803 Hamilton Road) asked if the Remsen Building was still tied up in court and it still could not be discussed and he was told yes. Mr. Vene asked if the lock boxes were electrical or digital. Chief Arbogast said they are mechanical.

John Basilone (4971 Shady Brook Run) said public comment is on the agenda, and when he has a question he doesn't know why he can't be recognized for his question. Mr. Ostmann said it is not required, by law, to have public comment and he asked Mr. Thorne if taking a question is different. Mr. Thorne said you don't have to allow public participation at all. Those in attendance have the right to listen but they don't have the right to make any comment. Mr. Basilone asked if they are saying legally they are not required to take comments and he asked where Mr. Thorne got that information. Mr. Thorne said it is in the Ohio Sunshine Law, you have the right to come and listen but you don't have the right to speak. Mr. Basilone asked if they follow Roberts Rules of Order and Mr. Ostmann said they have not adopted Roberts Rules of Order.

Mark Radice (4036 Stonegate Drive) asked what the September 11 emergency meeting was for. Mrs. Ventura said she asked for the meeting so she could move money to the zoning training line for the APA Conference. He asked why they asked for a safety service levy if we don't need the money for fire. Chief Arbogast said the Police Department may be a big benefactor and he was trying to be collaborative so the money could be used for Fire, Police and EMS. Mr. Radice said it could have been put off because the other departments don't need the money. Chief Arbogast said no, it couldn't have been put it off because he was trying to be collaborative so all departments could use it if need be. Mr. Radice said he understands. Mr. Ostmann said the Police are going to need more money and what they are trying to do is have the flexibility to be able to utilize the money for any department, Fire, Ems and Police. Mr. Radice asked what was going to happen to the \$900,000.00 in the fire fund and Mr. Ostmann said that will be used to pay for the fire contract for three and a half years. Mr. Radice asked where the safety services money was going to go and Mr. Ostmann said the money will be used where needed and the rest will be saved to use for either EMS or Fire.

Dave Clardy (3497 Old Weymouth Road) wanted to know who asked for the workshop meeting and was told the Fire Department requested the meeting. He asked how the request for a 3 to 5 mill levy for the Fire Department was determined and Mr. Ostmann said it was determined in the workshop and it is in the minutes. Mr. Clardy asked Chief Arbogast what his specific budget was and Chief Arbogast said he had a five year budget between now and 2022 that is very detailed but he doesn't have those numbers with him. He offered to provide them for Mr. Clardy and Mr. Clardy said no he just wanted to know how much of the 3 to 5 mil was for the Police. The 3 to 5 mil was only for Fire.

Matthew Galla (3503 Hamilton Road) asked what the Police budget was. Mrs. Ventura said the final appropriation was \$1,224,748.43. She said we don't appropriate everything because we have to have money to start our next year off. The Chief didn't expect to be paying off the leases on the Police cars but we did it to save interest. Chief Arbogast said what we spend is lower than Montville, Hinckley and Brunswick Hills and we have more calls.

PUBLIC COMMENT CON'T

John Basilone asked when the fire levy is stopped when it is retroactive to. Mr. Ostmann said it is not retroactive it is effective immediately. Mr. Ostmann said the tax collection is a year behind. Erica Graffein said that in January 2018 that particular levy will not be collected.

Mr. Ostmann motioned to close the floor for public comment. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. DeMichael and Mr. Jarrett.

Mr. Ostmann motioned to adjourn. Mr. Jarrett seconded the motion. Voting aye thereon: Mr. Ostmann, Mr. Jarrett and Mr. DeMichael. There being no further business to come before the Board the meeting was adjourned at 8:08 pm.
