

**RECORD OF PROCEEDINGS  
MINUTES OF PUBLIC HEARING

The Medina Township Board of Trustees held a Public Hearing at the Medina Township Hall on March 19<sup>th</sup>, 2018. Chairman DeMichael called the meeting to order at 7:01 pm with the following Trustees in attendance: Ken DeMichael, Mike Stopa and Mark Radice. Also in attendance were the Fiscal Officer and the general public.

**Roll Call**

Mr. DeMichael asked for a roll call of all members present. Trustees present were Mr. DeMichael, Mr. Stopa and Mr. Radice.

**Consideration of a Levy of an Annual Motor Vehicle License Tax**

Mr. DeMichael motioned to move to the Public Hearing portion of our meeting. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

The Medina Township Board of Trustees will hold two (2) public hearings to consider the levy of an annual motor vehicle license tax, pursuant to §4504.18 of the Ohio Revised Code, upon the operation of motor vehicles on the public roads and highways in the unincorporated territory of Medina Township. The tax shall be at the rate of five dollars (\$5.00) annually per motor vehicle on all motor vehicles the owners which reside in the unincorporated area of Medina Township. The special meetings and hearings will be held on March 19<sup>th</sup>, 2018 at 7:00 p.m. and on March 29<sup>th</sup>, 2018 at 7:00 p.m. at Medina Township Town Hall, 3799 Huffman Road, Medina, OH 44256.

Mr. DeMichael motioned to open the floor for public comment. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.


Mr. Radice explained that years ago they allowed \$40.00 in additional taxes and Medina Township never took advantage of that and there is only \$40.00 total. Mr. Basilone asked why we are taking advantage of it now when we have never taken advantage of it before. Mr. Radice said, as you know, we do not have a Road and Bridge levy so this will help supplement the Road and Bridge budget for culvert replacements. Mr. Radice said they found out about it at the Ohio Township Association Conference they attended last month.

Jim Burns, Hinckley Township Trustee, said they are going through the exact same process and that this is an additional tax.


Erica Graffain said she is not sure if it is an additional tax. The Trustees will look into it further and have answers before the next public hearing.
