

**RECORD OF PROCEEDINGS
MINUTES OF REGULAR MEETING
April 19TH, 2018
7:00 PM**

The Medina Township Board of Trustees met in regular session at the Medina Township Townhall on April 19th, 2018, to conduct the business of the Township. Chairman DeMichael called the meeting to order at 7:00 pm with the following Trustees in attendance: Ken DeMichael, Mike Stopa and Mark Radice. Also in attendance were Fiscal Officer Ventura, Police Chief Arbogast, Road Superintendent Miller, Zoning Inspector Ridgley and the general public.

Roll Call

Mr. DeMichael asked for a roll call of all members present. Trustees present were Mr. DeMichael, Mr. Stopa and Mr. Radice.

Pledge

Mr. DeMichael led the Pledge of Allegiance.

Moment of Silence

Mr. DeMichael asked for a moment of silence for our military both home and abroad as well as our first responders.

OTHER BUSINESS

Approval of Accounts Payables

Mr. DeMichael motioned to approve accounts payable check #29122 through check #29177 total amount \$79,708.56. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

Approval of Payroll

Mr. DeMichael motioned to approve payroll check #23916 through check #23939 total amount is \$31,514.86 with \$6,037.77 being deferred for employee discounts, OPERS, union dues, health insurance, etc. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

Mr. DeMichael motioned to approve the bank reconciliation dated 4/19/2018, the bank reconciliation statement 4/17/2018, it is a one page document as presented. Mr. Stopa seconded the motion. Mr. DeMichael amended his motion to be three (3) pages. Mr. Stopa seconded the amendment. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

It is for field three (3) renovations to infield and one (1) and two (2) maintenance. The total amount is \$12,450.00. Mr. Radice seconded the motion. Mr. Stopa asked what exactly was going to be done and Mr. Miller said they are going to laser grade field number three (3). Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

DEPARTMENT HEAD COMMENTS

Police Department

Chief Arbogast said May is bike safety month and Spin is donating a bicycle to give away also Wal-Mart gives a bike and a helmet. The drawing will be May 30th at Yours Truly Restaurant. Chief Arbogast will be making a personal donation to the 911 memorial in Medina City. He will make the donation on behalf of Medina Township Police Department.

Service Department

Mr. Miller said during the repair of the culvert on Cook Road they found that the whole box culvert is deteriorating and needs to be replaced. The County Engineer's Office recommends that we apply for OPWC grant money which will pay a certain percentage of the cost. We will find out in October if we get the grant money. Mr. Miller needs permission to have a letter sent to the Engineer's Office asking them to put us on the list for OPWC grant money.

Mr. DeMichael motioned to allow Denny to move forward with that grant. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

Mr. Miller said there is a lot of erosion on the side of the hill on Hood Road going up from Bagdad Road. There is actually a telephone pole hanging. He has been receiving calls from residents regarding this. The Engineer suggested setting up an information meeting on site. He asked Trustees to select a date when they can meet the Engineer on site. The meeting does not have to be advertised because it is an informational meeting and anyone can attend. The Trustees will meet Tuesday April 24 at 3:30pm.

CareWorksComp – Admin

Mr. DeMichael motioned to accept the purchase order for the Admin Department. The vendor is CareWorks out of Dublin Ohio. It's OTA 42 2019 Workers Comp Group Rating Program. \$3,256.00 is the total. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

Executive Session for the Potential Sale of the Remsen Building

Mr. DeMichael motioned to go into Executive Session for the potential sale of the Remsen Building with the three (3) Trustees and the Fiscal Officer and Denny Miller. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa. The Board entered into Executive Session at 7:15 pm. Mr. DeMichael motioned to come back from Executive Session at 8:00 pm where the three Trustees, Fiscal Officer and Denny Miller were talking about the potential sale of the Remsen Building. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

OLD BUSINESS

Discussion of Remsen Building

Mr. DeMichael allowed those in attendance to comment on the sale of the Remsen Building and asked that they limit themselves to a minute or so. Trustees will take into consideration their opinions. John Basilone said a \$100,000.00 offer was made on the building at the last meeting and asked if the Trustees have considered or begun negotiations on the offer received and have they secured an appraisal of the property. Mr. DeMichael said they have not had an appraisal and he doesn't think anyone on this Board or in this room thinks the building is only worth \$100,000.00. He thinks it is worth considerably more but because of the lease that is in place it creates a problem and whoever buys this building is going to lose money. Mr. Basilone said the offer was made by someone who knows of all the problems so what is your counter offer? Mr. DeMichael said an appraiser can say anything they want and we had an offer of \$300,000.00. Mr. Basilone said that offer is not there anymore and there are certified appraisers. Mr. DeMichael said they can put it up for auction or on the open market and he added that WPS is paying Creative Housing \$200.00 per month rent. Dan Tizzano asked who made the \$100,000.00 offer. Mr. DeMichael said it was Medina Soccer Association. Mr. Tizzano asked what the next step is. Mr. DeMichael said they would have to approve it as a Board and then Creative Housing has the opportunity per the lease to match that. Mr. Tizzano asked if Creative Housing has done that and he was told no. Mr. Tizzano asked if they would sell the building for \$100,000.00. Mr. Stopa said they would have to accept the bid from MSA before they would go to Creative Housing to see if they want to match it. Mr. Tizzano asked if this was a viable option to consider that bid. Mr. DeMichael asked viable option in so far as what? Mr. DeMichael said, you just heard how much money we're losing on a monthly basis so is it ideal to sell the building for \$100,000.00, no. Ideally if we could get out of the lease then the building would be worth more. Mr. Tizzano asked each Trustee if they would consider the \$100,000.00 offer and all three said yes. Mr. Radice said Medina Soccer made an offer at the last meeting and per the lease we have to supply this offer to Medina Creative Housing and feels Trustees should go ahead and do that. Mr. Radice told Mr. Jones that he is not sure if the timeline is going to fit into this offer because Ms. DePasquale-Hagerty has forty-five (45) days once she is notified. Mr. Jones said Trustees would have to accept the offer before they could notify her. Mr. Radice asked Mr. Jones if MSA will accept that forty-five (45) day time frame and that is from the day she is notified. Mr. Jones said if they vote on accepting it then he will put the revised date on the offer and he is sure it would get accepted. Mr. Radice said he would also like to send this to our attorney because of that forty-five (45) days and MSA has a fifteen (15) day window to do inspections that is going to incur some costs. Mr. Jones said it is okay to put a different date on the acceptance, which is fine. Mr. Radice asked Mr. Jones if he was okay with Trustees sending this to our attorney. Mr. Jones said he believes our attorney has a copy but that is fine. Mr. Radice said he hopes to have an answer for Mr. Jones at the next Trustees meeting. Jackie Smith asked why Trustees didn't want to get an appraisal of the building. Mr. Radice said he thinks the county has it appraised at \$300,000.00 but the issue is that there is work that needs to be done on the building. The roof needs to be repaired, there is another section of the building that may have to be torn down and there is an issue with the parking lot. Robin Gray asked if this is going to the County Prosecutor or outside counsel. Mr. Radice said it will go to the County Prosecutor. Ian Jones asked if it requires a unanimous vote to accept the offer and he was told yes.

PUBLIC COMMENT

Mr. DeMichael motioned to open the floor for public comment. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice. There was public comment.

Mr. DeMichael motioned to close the floor for public comment. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

Mr. DeMichael accepted a safety council award on behalf of Medina Township for its efforts in preventing accidents and injuries in the workplace.

Mr. DeMichael motioned to come back from Executive Session at 9:55 pm where we were with the three (3) Trustees and Fiscal Officer discussing, considering the employment and compensation of a public employee. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

Hiring of Matthew Schley as Administrative Assistant

Resolution #04192018-007

Mr. DeMichael put forth the following Resolution No. 04192018-007 that Medina Township hires an Administrative Assistant at a rate of \$15.00 an hour, full time hours with benefits and we offer that position to Matt Schley with a start date of May 3. We'll ask him to come in to our normal regularly scheduled meeting on May 3 would be the start date if he accepts and then this is also pending the pre-employment screening per our handbook. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.


Executive Session for Employee Discipline





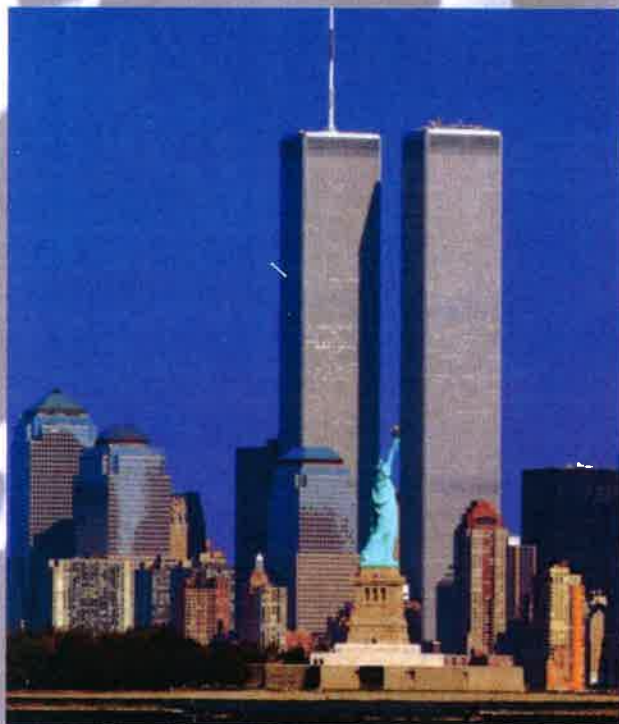

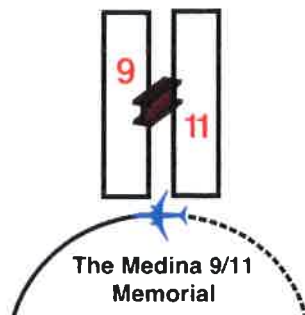
