#### RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING OCTOBER 4<sup>TH</sup>, 2018 7:00 PM

The Medina Township Board of Trustees met in regular session at the Medina Township Townhall on October 4<sup>th</sup>, 2018, to conduct the business of the Township. Chairman DeMichael called the meeting to order at 7:02 pm with the following Trustees in attendance: Ken DeMichael, Mike Stopa and Mark Radice. Also in attendance were Fiscal Officer Ventura, Road Superintendent Miller, Zoning Inspector Ridgley, Police Chief Arbogast, Fire Chief Painter and the general public.

#### Roll Call

Mr. DeMichael asked for a roll call of all members present. Trustees present were Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### Pledge

Mr. DeMichael led the Pledge of Allegiance.

#### **Moment of Silence**

Mr. DeMichael asked for a moment of silence for our military both home and abroad as well as our first responders.

#### SITE PLANS

#### <u>Hertz Car Sales – 2875 Medina Road – Site</u>

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the change of use for Hertz Car Sales to be located at 2875 Medina Road as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### Hertz Car Sales - 2875 Medina Road -Wall Sign

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the refacing of the existing wall sign for Hertz Car Sales located at 2875 Medina Road not to exceed 50.72 square feet and a re-facing of the existing ground sign not to exceed 67.11 square feet as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice

#### Heartland Pet Center - 3711 Pearl Road - Site

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the change of use for Heartland Pet Center, LLC to be located at 3711 Pearl Road as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### Heartland Pet Center - 3711 Pearl Road - Wall Sign

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve a wall sign for Heartland Pet Center, LLC located at 3711 Pearl Road not to exceed 38.25 square feet as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### <u>Heartland Pet Center - 3711 Pearl Road - Tenant Panel Sign</u>

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve a tenant panel sign to be placed on the existing pylon sign for Heartland Pet Center, LLC located at 3711 Pearl Road not to exceed 7.35 square feet as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice

#### Wendy's - 3067 Medina Road - Wall Sign (A)

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the refacing of the existing wall sign (submittal A) on the South elevation of the building for Wendy's located at 3067 Medina Road not to exceed 32 square feet as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### SITE PLANS CON'T

#### Wendy's - 3067 Medina Road - Second Wall Sign (B)

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the refacing of the existing second wall sign (submittal B) on the east elevation of the building for Wendy's located at 3067 Medina Road not to exceed 38.25 square feet as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### Wendy's - 3067 medina Road - High-Rise Sign

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the refacing of the existing high-rise sign for Wendy's not to exceed 127.6 square feet as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### Wendy's - 3067 Medina Road - Six (6) Directional Signs

Mr. DeMichael motioned to accept the recommendation of the Zoning Commission and approve the refacing of six (6) existing directional signs for Wendy's located at 3067 Medina Road not to exceed 4 square feet each as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### **OTHER BUSINESS**

#### Beth Schnabel - President of Bike Medina County

Beth Schnabel gave a presentation explaining the need for township roads that are not frequently traveled at 45 mph for possible bike routes and named several roads. She presented Trustees with two (2) maps showing bike routes. The State of Ohio passed a law that motorists have to give bicycles a three (3) foot passage. ODOT has an official sign that is to be placed on roads that have been designated by Counties, Townships etc. Bike Medina County is recommending that signs are placed on the Township roads she has designated so that motorists who are using the roads recognize that this is a route that can be used more frequently by bikers to bring up their awareness. The signs are being donated for the whole county. Ms. Schnabel asked the Township to install signs on several roads. Mr. Miller will count them and give her an amount. Mr. Miller asked who will install the signs. Ms. Schnabel said they will provide the signs but are asking the Townships to provide the posts, hardware and installation. Mr. Stopa asked that she let them know how many signs will be going up so Denny can get a cost.

Mr. DeMichael motioned to allow the eleven (11) signs for Bike Medina County. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

#### **Executive Session for Police Union Negotiations**

Mr. DeMichael wanted to pass along a couple of e-mails he received regarding the police union negotiations to Mr. Radice because he is spearheading this and he asked if he could let them know he is spearheading the negotiations.

Mr. Radice motioned to enter into an Executive Session to discuss negotiations on the police contract with the three Trustees, the Fiscal Officer, Police Chief and Mike Lyons from the Prosecutors Office. Mr. DeMichael seconded the motion. Mr. DeMichael asked Trustees if it would be agreeable to include John Basilone. Mr. Radice asked Mr. Lyons if that is an option. Mr. Lyons said at this state he would like to have a conversation with the Trustees before you brought him back. Voting aye thereon: Mr. Radice, Mr. DeMichael and Mr. Stopa. The Board entered into Executive Session at 7:25 pm. The Board reconvened from Executive Session at 8:11 pm where the three Trustees, Fiscal Officer, Asst. County Prosecutor Mike Lyons and our Police Chief were in session to discuss police contract negotiations.

#### **Approval of Supplemental Appropriations**

Mr. DeMichael motioned to approve supplemental appropriations dated 10/4/18 to cover expenses for the balance of 2018 and incorporate this one page document by reference. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

#### PURCHASE ORDERS AND TRAINING REQUESTS

#### Perfect Voice & Data – Police

Mr. Radice motioned to approve a purchase order for the total \$2,889.00 to Perfect Voice and Data for the Police Department. Mr. DeMichael seconded the motion. Mr. Radice said it is to transfer Police Department phones over and it will save over \$200.00 a month. Voting aye thereon: Mr. Radice, Mr. DeMichael and Mr. Stopa.

#### Pro-Tech - Police Vests

Mr. Radice motioned to approve a purchase order to Pro-Tech for eleven (11) vests. The total is \$9,398.00, of that 75% will be paid by a grant. We'll pay for it all up front and we'll get reimbursed. It will be \$7,048.50 to the grant and our portion will be \$2,349.50. Mr. DeMichael seconded the motion. Voting aye thereon: Mr. Radice, Mr. DeMichael and Mr. Stopa.

#### Vasu Communications - Police Handheld Radios

Mr. Radice motioned to approve a purchase order for Vasu Communications for fifteen (15) handheld portable P25 Radios and two (2) mobile P25 radios totaling \$24,458.40. Mr. DeMichael seconded the motion. Chief Arbogast said the P25's is a federal requirement and we are able to use some of our equipment by going with Kenworth instead of Motorola at a lesser price. Mr. DeMichael said there are requirements coming and he asked Officer Justin Harvey if he saw the benefits for this now and Officer Harvey said yes, absolutely, there had been times when they had lack of radio contact with our dispatch, with other officers when we are in larger buildings or in a more remote area. There are times when he has gone to Brunswick City to pick up someone who has a warrant and we will lose radio contact with our dispatch. Having the ability to have contact with dispatch is a benefit. Mr. DeMichael asked if this will correct that. Officer Harvey said yes. Voting aye thereon: Mr. Radice, Mr. DeMichael and Mr. Stopa.

#### Melway Paving Company - Huffman Road

Mr. DeMichael motioned to accept a purchase order requisition for our Service Department. The vendor is Melway Paving Company out of Homersville, Holmesville. This is to repair Huffman Road between Fenn and Route 3. \$45,000.00 is the total. Mr. Stopa seconded the motion. Mr. Radice asked if that was part of the plan. Mr. Miller said they are cutting six(6) inches of asphalt and putting base asphalt all the way back up and then next year coming and milling two (2) inches off the whole top and then do what we did with all the other roads, this will get us through the winter. Mr. Stopa said Denny held off doing this because of the new development on Huffman Road. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### **OTHER BUSINESS**

#### **Approval of Bank Reconciliation**

Mr. DeMichael motioned to approve the bank reconciliation dated 8/31/2018 as presented. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

#### **Approval of Accounts Payable**

Mr. DeMichael motioned to approve accounts payable check #29489 through check #29524. The total amount is \$31,765.40. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

Mr. DeMichael motioned to approve accounts payable check #29526 through check #29551. Total amount is \$75,224.87. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa.

Mr. DeMichael asked if the Frontier cancellation was resolved. Mr. Stopa said we need to speak to Neil to be sure everything was ported over correctly and he was out of town last week. We also have a call in to our Frontier representative. If need be we will call customer service. Mrs. Ventura said she hoped they credit us when they see the ported over date. Mrs. Ventura also said only Celia can cancel things and she feels we should come up with a standardized letter that pretty much spells out who the new Board is and will give anyone the authority to do these kinds of things. Mr. DeMichael asked if Celia was the only one who could do the phones and Mr. Stopa said yes. Mrs. Ventura said Celia is the only one left who can do this. Mrs. Ventura said they will draft a letter to present to any company where a person with authority can make changes.

#### OTHER BUSINESS CON'T

#### **Approval of Payroll**

Mr. DeMichael motioned to approve payroll check #24206 through check#24225. Total amount is \$32,236.96 with \$6,238.79 being deferred as well as check #24226 through check#24249. Total amount on this is \$37,474.37 with \$6,977.80 being deferred. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### **Department Reports**

Mr. Stopa motioned to accept the reports from the Fire Department, Police Department and Zoning Department as submitted for August 2018. Mr. Radice seconded the motion. Voting aye thereon: Mr. Stopa, Mr. Radice and Mr. DeMichael.

#### **DEPARTMENT HEAD COMMENTS**

#### **Police Department**

Chief Arbogast attended a NOACA meeting and representatives from ODOT were there. He expressed his concerns about not having turn arrows at Stonegate and Grande Blvd. He also asked about the Route 3 and Fenn Road intersection. He said they are addressing the turn lane issue.

The Medina Township Police Department and Pat O'Brien Chevrolet will be hosting the 3<sup>rd</sup> Annual Kids Costume Party October 31 from 4 to 6 pm at Pat O'Brien's.

Mr. DeMichael said it has been brought to his attention about landscaping vehicles parking on the roads. Chief Arbogast is checking the ORC to see if there is a solution to this issue. Mr. DeMichael said there is an area on Huffman Road as you come over the hill; you can't see the vehicle which is a safety issue. Chief Arbogast said there are hazards that are not illegal and he is trying to come up with a solution. The Chief said one solution is to identify every road or at least areas of roads and you can decide on going from point A to point B on both sides and post them with no parking signs. The Chief has reached out to other Chiefs in other Townships to help him find a solution. Mr. Radice has asked the Chief to come up with at least a departmental policy for now to make sure we are stopping and asking them to move their trucks inaudible until we get a resolution to have everyone on the department inaudible. Chief Arbogast said every time we gets call we go out there and ask them to move inaudible.

#### Fire Department

Chief Painter said they have been working on annual hydrant maintenance and in two (2) weeks we will be doing the annual pump tests and ladder tests.

#### **OLD BUSINESS**

#### **Discussion of Hood Road**

Mr. DeMichael spoke with Mr. Miller this morning and we are still waiting to hear from the County Engineer. So we don't have anything to go on. Mr. Miller said the County did put some preliminary numbers together to move the road over a couple of feet, put a new curb and new guard rail with OPWC money. Mr. DeMichael said we are applying for a grant to pay for a portion of it with the County. Mr. DeMichael asked if those were hard numbers and Mr. Miller said no, they are figuring about \$110,000.00 and we have to pay 26%. Gene Mizoris (3426 Hood Road) asked if there was a certain amount of feet a new road had to be from an existing structure. Mr. Miller will look into it.

#### **NEW BUSINESS**

#### Pine Lake Drive Fall Fest - Request for Barricades

Mr. DeMichael motioned to have Pine Lake Road barricaded Saturday October 27<sup>th</sup> from 3 to 5 pm. Mr. Radice seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Radice and Mr. Stopa

#### **NEW BUSINESS CON'T**

#### Trick or Treat - October 31, 2018

Mr. DeMichael motioned to have Medina Township's Trick or Treat date set for October 31<sup>st</sup> from 6 to 8 pm. Mr. Stopa seconded the motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### Resolution Accepting the Amounts & Rates of the Budget Commission

#### Resolution #10042018-017

Mr. DeMichael motioned to accept the Official Certificate of Estimated Resources Resolution as presented. It is a sixteen (16) page document. Mr. Stopa seconded the motion. Mr. DeMichael amended his motion to include the Resolution #10042018-017. Mr. Stopa seconded the amended motion. Voting aye thereon: Mr. DeMichael, Mr. Stopa and Mr. Radice.

#### Resolution for Application for OPWC Monies for Hood Road

#### Resolution #10042018-018

Mr. DeMichael motioned to approve Resolution #10042018-018 a Resolution authorizing Medina Township to prepare and submit application to participate in the Ohio Public Works Commission State Capital Improvement and /or Local Transportation Improvement Program(s) and to execute contracts as required.

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

WHEREAS, the Medina Township is planning to make capital improvements to T.H. 130 Hood Road between Bagdad Road and Cook Road, and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs,

NOW THEREFORE BE IT RESOLVED, by Medina Township:

Section 1: The Medina Township Trustee Ken DeMichael is hereby authorized to apply to the OPWC for funds as described above.

Mr. DeMichael motioned to roll back the Safety Services Levy that we currently have in place. Mr. Radice seconded the motion. Roll call vote: Mr. DeMichael aye, Mr. Radice no and Mr. Stopa no.

Mr. Stopa told Mr. Krepp he hasn't had an answer from the County Engineer regarding the slow moving vehicle signs people have at their driveways. The Engineer's office is busy trying to finish projects before winter but Mr. Stopa will follow up with them.

#### **Fire District Meeting**
