The first of the month I imagine. Ken DeMichael withdrew his motion. Mr. Radice seconded. Instead Mr. DeMichael moved to offer Nick Dominguez the job of administrative assistant at \$20 per hour starting June 1, 2019. Mr. Radice seconded. Now is June 1st a good date? Mr. Stopa asked when the start of payroll is? Mr. DeMichael said Nick had school until Memorial Day. They are done on the 30th, 30th is the last day. Then he is done. Mr. Stopa stated we got payday this week payday the 30th, Mr. Radice asked Mr. DeMichael to amend it again for the 3rd time. Just a start date to determine if he accepts. Will that be fair then you will have time to work out that date with him. Mr. DeMichael withdrew his motion. Mr. Radice seconded. Mr. DeMichael moved to offer the administrative assistant position to Nick Dominquez starting payrate \$20 per hour and the start date to be determined likely the beginning of June. Mr. Radice seconded. Voting aye thereon: Mr. DeMichael, Mr. Radice, Mr. Stopa
