	stated that he will look into this matter with the assigned
	law firm. The Board further discussed the steps that were
	skipped in order for the law firm to represent the Township
	and what would need to now be done to ensure the
	Township is properly represented. For the record, Mr. Stopa
	stated that nothing has been signed stating that the the law
	firm in question is representing Medina Township and that
	he would contact them to have all paperwork prepared for
	Trustee approval at a public meeting. Mrs. Ventura stated
	that there will be a deductible associated with the legal
	service that will need to be addressed on a purchase order.
